Carter and Mary Wylie; that service was perfected upon John W. Downer, Alabama Tobacco Company, a corporation, Mary Wylie, Emmie S. Carter by publication in the Baldwin Times, a newspaper published at Bay Minette, in Baldwin County, Alabama, for four consecutive weeks, commencing on the 31st day of July, 1952; that service was perfected by publication in the Baldwin Times, a newspaper published at Bay Minette, in Baldwin County, Alabama, for four consecutive weeks, beginning with its issue of July 31, 1952, against the unknown heirs, devisees, grantees, personal representatives and assigns of the Respondents herein and each of them, and any and all other persons, firms or corporations claiming any right, title to, interest in, lien or encumbrance upon the said land or any part or parcel thereof; that notice of the pendency of said suit was given by the filing of a lis pendens notice in the office of the Probate Judge of Baldwin County, Alabama, and by posting at the court house door in Bay Minette, Alabama; that the Respondents and each of them having failed to appear and plead, answer or demur to the bill of complaint, as required by law, a decree pro confesso was entered against them and each of them; that Harry J. Wilters, Jr., a practicing attorney at law, in Bay Minette, Baldwin County, Alabama, was appointed as Guardian ad Litem to represent the Respondents whose names were unknown, and duly filed his appearance agreeing to act as Guardian ad Litem and filed answer denying all the material allegations of the complaint, and appeared and cross examined

the witnesses for the Complainant; that the title of the Complainant has been duly and legally established by legal and competent evidences, the court is of the opinion that the Complainant is entitled to the relief prayed for.

IT IS, THEREFORE, ORDERED, ADJUDGED AND DECREED, by the court, that the Respondents, John W. Downer, Alabama Tobacco Company, a corporation, Mary Wylie, Emmis S. Carter, the unknown heirs, devisees, grantees, personal representatives and assigns of John W. Downer, Alabama Tobacco Company, a corporation, Mary Wylie, Emmis S. Carter, and also any and all persons, firms or corporations claiming any right, title to, interest in, lien or encumbrance upon the said land or any part or parcel thereof, have no right, estate, claim, interest in or encumbrance upon the following described lands or any part or parcel thereof in Baldwin County, Alabama, to-wit:

Farm Lots 5, 6, 7 and 8 in Farm 12 as per plat of file in the office of the Alabama Tobacco Company, being the South half of the Northwest quarter of the Southwest quarter of Section 16, Township 6 South, Range 5 East, containing 20 acres, more or less.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED, by the court, that the full fee simple title to the said land in Baldwin County, Alabama, to-wit:

Farm Lots 5, 6, 7 and 8 in Farm 12 as per plat on file in the office of the Alabama Tobacco Company, being the South half of the Northwest quarter of the Southwest quarter of Section 16, Township 6 South, Range 5 East, containing 20 acres, more or less,

is vested absolutely in the Complainant, State Bank of Elberta, a corporation.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED, by the Court, that a certified copy of this decree be recorded in the office of the Probate Judge of Baldwin County, Alabama, in the direct index in the names of John W. Downer, Alabama Tobacco Company, a corporation, Mary Wylie, Emmie S. Carter, and in the indirect index in the name of State Bank of Elberta, a corporation.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED, by the Court, that the Register shall within thirty days from the rendition of this decree file a certified copy hereof in the office of the Judge of Probate of Baldwin County, Alabama, and that the costs thereof be taxed in the costs of this cause.

IT IS FURTHER ORDERED that the Complainant pay the costs of this cause for which execution may issue.

My name is Alfred M. Neumann. I am Cashier of the State Bank of Elberta. The State Bank of Elberta is a corporation organized and existing under the laws of the State of Alabama with its principal place of business at Elberta. I, as Cashier and managing Officer of the State Bank of Elberta have made and caused to be made a diligent search and inquiry as to any parties claiming to have any interest in the property described in the bill of complaint in this cause being the South half of Northwest quarter of Southwest quarter of Section 16, Township 5 South, Range 5 East, Baldwin County, Alabama. John W. Downer so far as I know and have been able to find out has never been a resident of the State of Alabama, however, he is over twenty-one years of age and his address cannot be ascertained after a diligent search and inquiry. The Alabama Tobacco Company at one time did an extensive business in Baldwin County, Alabama. It was a corporation. There is no one at this time resident of Baldwin County, Alabama, upon whom service could be perfected. The corporation so far as I know no longer is in existence and does not carry on its business in Baldwin County.

Mary Wylie and Emmie S. Carter are both over twenty-one years of age and resident of Montgomery. I have caused an abstract of the records to be made of the said land to ascertain and determine any claimants. The State Bank of Elberta is the owner in fee simple and in the actual possession of the lands herein described having acquired the same through a foreclosure deed from Will Williams and Annie Williams dated December 3, 1951, and of record in the Probate Judge of Baldwin County, Alabama, in Deed Book 174, pages 288-9. The said foreclosure deed is hereto attached and made a part of my testimony.

The said Will Williams and Annie Williams for a number of years held and were in possession of the said land and no one has at any time exercised or attempted to exercise any rights of possession contrary to their claim. Will Williams and Annie Williams acquired title in January 17, 1944, from Ella Shirey and others which deed is of record at the office of the Probate Judge of Baldwin County, Alabama, in Deed Book 86 pages 396-7.
