

I own the following described piece of land and am now in possession of it:

Lots Twenty-eight (28) and Twenty-nine (29) in Block Sixteen (16) Volanta, Alabama, all being according to the Map of Volanta, Alabama recorded in Miscellaneous Book No. One (1) at page Three Hundred Forty-One (341) as signed by Theo. Widell, Surveyor, April 27th, 1914, Land is situated in Section 37, Baron De Feriet Grant, Township Six (6) South, Range Two (2) East, Baldwin County, Alabama.

I have been in peaceable, adverse possession of this land since the time it was sold to me, that being in February, 1942.
