Patterson, Randolph Garbe, Louisa Garbe, Ellen Hill, Ethel Hoyle, Henry Hill, Major Smith, J. F. Crance, John C. Allen, if living are Non-residents of the State of Alabama, and over twenty-one years of age, and that if dead their heirs, devisees, grantees, personal representatives and assigns are non-residents of the State of Alabama and over twenty-one years of age; that service was perfected upon the Respondents herein by publication in the Baldwin Times, a newspaper published at Bay Minette, in Baldwin County, Alabama, for four consecutive weeks commencing on the 2nd day of October, 1952; that service was also perfected by publication in the Baldwin Times, a newspaper published at Bay Minette, in Baldwin County, Alabama, for four consecutive weeks commencing on the 2nd day of October, 1952, against the unknown heirs, devisees, grantees, personal representatives and assigns of P. D. Ballard, Hattie M. Ballard, Estelle E. Ballard McKibbon, Isabelle V. Robertson, J. Bestor Robertson, Esther Banning, A. J. Patterson, Randolph Garbe, Louisa Garbe, Ellen Hill, Ethel Hoyle, Henry Hill, Major Smith, J. F. Crance, John C. Allen, and any and all other persons, firms or corporations claiming any right, title to, interest in, lien or encumbrance upon the said land, or any part or parcel thereof; that notice of the pendency of said suit was given by the filing of a lis pendens notice in the office of the Probate Judge of Baldwin County, Alabama, and by posting at the court house door in Bay Minette, Alabama; that the Respondents and each of them, having failed

Bestor Robertson, Esther Banning, A. J. Patterson, Randolph Garbe, Louisa Garbe Ellen Hill, Ethel Hoyle, Henry Hill, Major Smith, J. F. Grance, John C. witnesses named in the Requirement for Oral Examination, on the 16 day of December 1945, at the office of Hubert M. Hall in Bay Minette, Alabama, and having first sworn said Witness to speak the truth, the whole truth, and nothing but the truth, the said Hazel Council and A. C. Council Jr. doth depose and say as follows:

Hazel Council, a witness for the Complainant being duly sworn, deposes and says: My name is Hazel Council. I live at Daphne, in Baldwin County, Alabama, I am personally acquainted with and have known the Complainant, E. T. Doehring, a resident of Baldwin County, Alabama, for the past 30 years. I know that he is over twenty-one years of age. I am a real estate broker and have for the past 12 years represented Dr. E. T. Doehring in all of his Baldwin County land transactions. I also represented the Mo-Baldwin Development Company of which Dr. Doehring was president and the principal stock holder and owner. I represented Dr. Doehring in the possession of the lands described in the bill of complaint in this cause and it was through my recommendation and report of the nature and type and possession of the said property that Dr. Doehring bought it. I, before perfecting a purchase by Dr. Doehring made a personal inspection of the properties in this suit and I am fully acquainted with all of them.

I also, as Agent for Dr. Doehring, made a full, complete and thorough investigation and inquiry as to any parties that might have a claim to said property including a search of the records at Bay Minette, Alabama. I also arranged with Hubert Hall, an attorney at Bay Minette, Alabama, to make a record search as to said property and to determine as to any claimants. The parties named in the bill of complaint as respondents are the only ones found that might have any claims against the said property, and any claim that any of the named respondents might have had has long since been barred by estoppel and possession on the part of Dr. Doehring and those through whom he claims. The addresses of the Respondents as given in the original bill of complaint are true from all information obtainable.

It was determined after a full inquiry that none of the Respondents were presently residents of the State of Alabama, but non-residents of the State of Alabama, and their addresses could not be ascertained. It was also impossible to ascertain as to which of the non-residents were dead, however, so far as information is available none of the heirs are residents of the State of Alabama.

The Complainant is the owner in fee simple and in the actual possession of the land described in this bill of complaint having acquired the same by conveyances from Mo-Baldwin Development Company Inc; that said deeds as described in the bill of complaint are hereto attached and are to be taken as a part of my testimony as though they were herein fully set out.

I know of my own personal knowledge that there is no suit pending to test the Complainant's title to, interest in, or rights of possession to said lands.

The title to the said lands, involved in this suit stands upon the records of the Probate Court of Baldwin County, Alabama, in the name of E. D. Doehring and no one has at any time within ten years next preceding the filing of the bill of complaint in this cause paid any taxes upon or had any possession of said lands or any part thereof other than the Complainant, E. T. Doehring and those through whom he claims by mesne conveyances. Practically all if not all the lands involved in this suit are now under fence and have been for more than 10 years. I know that during the said time no one has claimed or attempted to exercise any claims or rights of possession to said lands other than E. T. Doehring and those through whom he claims.

Cross Examination by guardian ad litem:

I having represented Dr. Doehring in the purchase of his lands and I am much better acquainted therewith than he is personally. I have had the responsibility of looking after his holdings for the past 12 years and he has during that time depended upon me to look after all his lands in Baldwin County, Alabama. I have known Dr. Doehring since 1921.

Hazel Council

A. C. Council Jr., a witness for the Complainant being first duly sworn, deposes and says:

My name is A. C. Council Jr., I live at Daphne in Baldwin County, Alabama. I am now and have been for the past five years a real estate salesman working under Miss Hazel Council. I am personally acquainted with Dr. E. T. Doehring the Complainant in this case and also know and have known for the past 17 years and more the lands described in the bill of complaint in this cause. I have, working with Miss Council, made diligent inquiries and searches to ascertain the addresses of the parties named as respondents in this cause, however, have not been able to ascertain them. I know that they do not live anywhere within the vicinity of the land and from all information obtainable they are if living non-residents of the State of Alabama. This property is located at what is called Seacliff between Daphne and Fairhope and I have been along by or near the property several times weekly for the past 10 years or more. I have also been on the property repeatedly checking it and its boundaries and know that no one has for the past 10 years exercised any rights of possession or attempted to exercise any title to the said land adversely to the Complainant and those through whom he claims.

Miss Council and I have represented the Complainant for many years and he has relied upon us to take care of his properties and we are in much better position to testify than Dr. Doehring himself.

Cross Examination by guardian ad litem:

I know that a greater part if not all of the lands involved in this suit is now and has been for the past 10 years under fence and that the Complainant and those through whom he claims have exercised full and complete possession of said property under claims of ownership. Just recently the Complainant deeded to Baldwin County and to the Town of Fairhope rights of ways for roads through the properties involved in this suit.

Your Complainant prays for such other, further, different or general relief as he may be in equity and good conscience entitled to receive.




