TO THE HONORABLE HUBERT M. HALL, JUDGE OF THE CIRCUIT COURT OF BALDWIN COUNTY, ALABAMA, IN EQUITY SITTING:

Your complainant, ERNESTINE MILLER HOWARD, respectfully represents unto your Honor and this Honorable Court as follows:

- 1. That your complainant is over the age of twenty-one years and is a bona fide resident citizen of said State and County; that GENE FERRELL HOWARD is over the age of twenty-one years and is a non-resident of the State of Alabama;
- 2. That your complainant and the respondent were lawfully married at Bay Minettek Alabama, on, to-wit: the 26th day of October, 1957;
- 3. That almost as soon as they were married the respondent began to exhibit a violent temper; that he has made numerous threats of doing your complainant physical harm and, from his manner and conduct toward her, she is reasonably convinced that, should she continue to live with him as his wife, he will commit an actual violence on her person which will necessarily endanger her life or health; that, because of the respondent's treatment of your complainant, your complainant has been forced to separate from him, on, to-wit: the 14th day of November, 1957; and that she does not intend to return to live with him as his wife.

WHEREFORE, THE PREMISES CONSIDERED, your complainant makes the said GENE FERRELL HOWARD a party respondent to this bill of complaint, and, in der that complainant may have the relief hereinafter prayed for, may it please your Honor to cause the State's Writ of Subpoena to be issued, directed to the said GENE FERRELL HOWARD, commanding him to plead, answer or demur to this bill of complaint within the time required by law.

Your complainant further prays that, on a final hearing of this cause, your Honor will make and enter a decree forever divorcing your complainant from the respondent, and granting to your complainant the right to resume the use of her former name,
