This cause coming on to be heard was submitted upon Bill of Complaint, Decree Pro Confesso on Answer and Waiver and Testimony as noted by the Register, and upon consideration thereof, the Court is of the opinion that the Complainant is entitled to the relief prayed for in said bill.

It is therefore ordered, adjudged and decreed by the Court that the bonds of matrimony heretofore existing between the Complainant and Defendant be, and the same are hereby dissolved, and that the said Robert A. Switzer is forever divorced from the said Glenda Switzer for and on account of

cruelty; the agreement of parties with reference to custody of children, support of children, and property rights is approved in all respects, is incorporated into and as a part of this decree, and it is further ordered, adjudged and decreed by the Court that the parties shall obey and abide by its terms.

It is further ordered, adjudged and decreed that neither party to this suit shall again marry except to each other until sixty days after the rendition of this decree, and that if appeal is taken within sixty days, neither party shall again marry except to each other during the pendency of said appeal.

It is futher ordered that the Complainant and Respondent be, and they are hereby permitted to again contract marriage upon payment of the cost of this suit.

It is further ordered that Robert A. Switzer the Complainant pay the cost herein to be taxed, for which executed may issue.





Comes the former Complainant, and now Respondent in the above styled cause, and demurs to the Petition filed in said cause in its several aspects and as grounds therefor, says;

1. As to that aspect of the Petition as set out in paragraph "3," the now-Respondent assigns the following separate and several grounds, viz:

- a. That the allegations are too general.
- b. That it is not stated what was the nature of the false and fraudulent statements, or other inducements.
- c. That it is not stated what sort of promises were made to her, nor that the said Robert A. Switzer has failed to keep any such promises.
- d. That the details of the statements, inducements, and promises are not set out to enable the said Robert A. Switzer to be informed of the nature of Petitioner's allegation.

2. As to that aspect of the Petition as set out in Paragraph "4", the now-Respondent assigns the following separate grounds, VIZ:

- a. For aught that appears the allegation that there has been a change in the moral and mental condition of the said Robert A. Switzer resulting in it being presently in the best interests of the minor children to be in the care, custody and control of the Petitioner is but a conclusion of the pleader.
- b. It is not alleged what sort of change in moral and mental condition has taken place in the said Robert A. Switzer.
- c. That there is a fatal variance in said paragraph inasmuch as Petitioner has alleged the said Robert A. Switzer acted fraudulently at the time of the divorce in obtaining her

signature on the Agreement as to custody while in this paragraph she alleges that he has become mentally and morally unfit only since the divorce.

3. As to that aspect of the Petition as set out in Paragraph "5", the now Respondent assigns the following and separate and several grounds, VIZ:

a. It is not alleged what conditions now existing necessitate a change of custody of the minor children.

b. The allegations are too general.

4. As to that aspect of the Petition as set out in paragraph "6", the following separate and several grounds, VIZ:

a. It is not alleged that the Petitioner is not a fit and proper person to have the control of the minor children of the marriage.

b. It is not alleged when the said Robert A. Switzer ceased to be a fit and proper person to have control of the minor children of the marriage.

5. As to that aspect of the Petition set out in paragraph "8", the now Respondent assigns the following grounds, VIZ:



a. It is not alleged upon what instances the new Respondent has endangered the lives and safety of the minor children.



Comes your Complainant, Robert A. Switzer, and respectfully shows unto this Honorable Court as follows:

1. 2. That on, to-wit: the 27th day of June, 1953, your Complainant and the Respondent were intermarried at Sarasota, Sarasota County, Florida, and that your Complainant and the Respondent are still lawfully married.

3. That there has been born of said marriage two minor shildren, whose names and ages are respectively: Robert A. Switzer, age four; and John Lee Switzer, age three. That said minor children are in the custody of the Complainant.


4. That Complainant and Respondent have entered into an agree- ment with reference to a property settlement, and custody of minor children, which is attached as EXHIBIT A and made a part hereof.

5. Your Complainant further avers and charges that on the 20th day of April, 1958, the Respondent, without cause or justifi- cation, using her hands and closed fists and a heavy blunt instru- ment, struck and beat your Complainant about the face and body a

number of times, inflicting bruises and injuries upon the body of your Complainant, attended with great danger to his health and life; and from her manner and conduct toward him he is reasonably convinced that she will commit further actual physical violence upon his person attended with danger to his health and life; that on, to-wit; the 20th day of April, 1958, she separated from and abandoned the Complainant, and is now living separate and apart from him.

PRAYER FOR PROCESS AND RELIEF

THE PREMISES CONSIDERED, your Complainant prays that Glenda Switzer be made a party respondent to this cause by the usual process of this Honorable Court, requiring her to plead, answer, or demur within the time and under the penalties prescribed by the rules of this Court, and the statutes in such cases made and provided; that upon a final hearing of this cause, that your Complainant be granted a divorce from the Respondent, without the payment of any alimony or support to the Respondent; and that he be granted the care, custody, and control of the two minor children of the marriage, with reasonable rights of visitation to the Respondent. 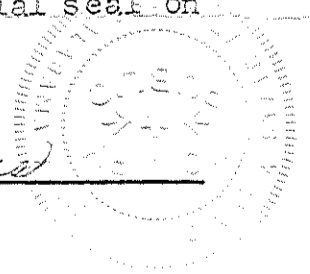

AGREEMENT OF PARTIES CONTEMPLATING A DIVORCE WITH  
REFERENCE TO CUSTODY OF CHILDREN, SUPPORT OF  
CHILDREN, AND PROPERTY RIGHTS

THIS AGREEMENT, made and entered into in triplicate, by and between Robert A. Switzer, hereinafter called husband, and Glenda Switzer, hereinafter called wife, WITNESSETH:

That whereas, various and diverse disputes and unhappy differences have arisen between husband and wife, and they are separated and not now living together as husband and wife, and whereas it is the desire of the parties hereto to make a complete and final settlement of all their property, and to settle and adjust all marital interests, now, therefore, this agreement is made as follows:

1. The husband shall have the permanent care, custody, and control of the minor children, Robert A. Switzer, age four, and John Lee Switzer, age three; the wife shall have the right of visitation at reasonable times and places.
2. The husband further agrees and does hereby release and transfer to the wife as her sole property, all furniture and household furnishings owned by the parties that is now in possession of the wife.
3. It is agreed and understood by the parties that in consideration of this agreement, no further alimony shall be due or shall grow due between these parties.
4. It is further agreed that any and all property acquired by either parties subsequent to the date of this agreement shall be the separate property of said party acquiring the same; and each party agrees to execute for the other any and all papers necessary to complete the transfer of property herewith divided and apportioned. It is further agreed that the terms of this agreement may be incorporated in any decree of divorce which may be hereafter obtained by either party, and enforced by contempt proceedings if necessary.

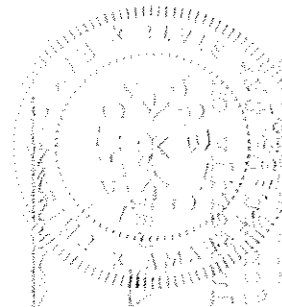

Now comes your Petitioner, Glenda Switzer, who was the Respondent in the above styled cause, and respectfully represents and shows unto this Honorable Court as follows:-

1. That on, to-wit, May 16, 1958, the Complainant and the Respondent in the above styled cause entered into an agreement of separation in contemplation of divorce, wherein it was agreed that Robert A. Switzer should have custody and control of the minor children of this marriage, namely, Robert A. Switzer, who was 4 years of age, and John Lee Switzer, who was 3 years of age.

2. That on, to-wit, May 23, 1958, a Decree of Divorce was signed by this Honorable Court approving in the said Decree the agreement as to custody of the said minor children.

3. That on the same date as the execution of the agreement hereinabove referred to, your Petitioner executed an Answer and Waiver to the divorce proceeding, and she further shows that the said Robert A. Switzer, the Complainant, obtained her signature to the said Agreement and the said Answer and Waiver by false and fraudulent statements, promises to her, and by other inducements.

4. That there has been a change in the moral and mental condition of the said Robert A. Switzer since the date of the issuance of the Decree of Divorce, resulting in it being presently to the best interests of the minor children to be in the care, custody and control of your Petitioner.

5. Under conditions now existing, a change of custody of the minor children of this marriage from the said Robert A. Switzer to your Petitioner, will materially promote the children's welfare.

6. That Robert A. Switzer is not now a fit and proper person

to have control of the minor children of this marriage, and that it would be to their best interest to be in the care, custody and control of your Petitioner.

7. That your Petitioner is over the age of twenty-one years and a resident citizen of Foley, Baldwin County, Alabama; that Robert A. Switzer is over the age of twenty-one years and is presently a resident citizen of Baldwin County, Alabama, and that the minor children of their marriage are presently residing in Baldwin County, Alabama. Petitioner further shows, however, that Mrs. Goldie Switzer, who is a resident of Ohio Trailer Park, Sarasota, Florida, has had the children with her on occasions, and that she is now at Foley, in Baldwin County, Alabama. Petitioner fears, believes and therefore alleges that the said Robert A. Switzer intends to send the children to the home of his mother in Sarasota, Florida, therefore, outside of the jurisdiction of this Court.

8. Petitioner further shows that Robert A. Switzer has failed to give the said minor children of this marriage proper care and supervision, and further shows that on several instances he has endangered their life and safety.

9. Petitioner further shows that Robert A. Switzer is gainfully employed, and is informed and believes, and on information and belief, alleges that he receives between One Hundred twenty-five Dollars (\$125.00) and One HUNDred Fifty Dollars (\$150.00) per week for his work and labor.

WHEREFORE, THE PREMISES CONSIDERED, your Petitioner prays that your Honor will, by proper process, make the said Robert A. Switzer a party to this cause, requiring him to plead, answer or demur to the same within the time allowed by Law and under the penalties by Statute made and provided.





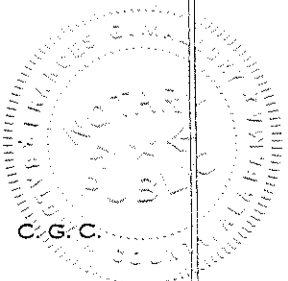

My name is Robert A. Switzer; I am the Complainant in the divorce  
action now pending in the Baldwin County Circuit Court wherein my wife,  
Glenda Switzer is respondent; I am 23 years old and my wife is 22  
years old; we were married at Sarasota, Florida on June 27, 1953, are  
still legally married, and we have two sons, Robert, 4, and John Lee,  
3; we have been living in Foley, Alabama, about three years; I am  
working in Foley as the engineer for the Foley radio station, and I  
also work in Bay Minette as engineer for the radio station there.

My work often requires me to be out at night; this was the case  
on the night of April 19, 1958; I was very tired and fell asleep  
immediately; my first memory afterward was waking with a loud ringing  
in my ears, a big lump on my head, and when I opened my eyes I saw my  
wife standing over me with a croquet mallet in her hands; she said she  
was fed up with me, and she was going to fix me good; before I could  
get out of bed, she swung the mallet at me again, hitting me in the  
left ribs; this doubled me up with pain, and she then began scratching  
me and hitting me about the face; then she left the room and picked up

a suitcase and walked out of the house, leaving me to work and try to take care of the children; she has moved twice, and now stays at the Foley Hotel; we have signed a custody and property settlement.
