

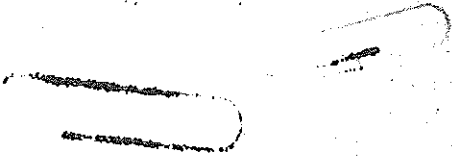

Your Oratrix, Ella F. Lambert, respectfully represents and shows unto your Honor as follows:

FIRST.

That she is a married woman and a bona fide resident citizen of the County of Baldwin and State of Alabama, and over the age of Twenty-one years.

That James W. Kinmon is a non-resident of the State of Alabama and his place of residence or address is unknown. That he is over the age of Twenty-one years.

SECOND.

That your Oratrix is the owner of and is now in the peaceable possession of the following described real estate, situated, lying and being in the County of Baldwin, State of Alabama, to-wit:

Starting at a post in the Southwest corner of the Northwest quarter of the Southeast quarter of Section Twenty-seven, township Two South of Range Three East, run thence East 220 yards; thence run North 310 yards to a post at T.
