My husband is over the age of twenty-one years and resides at Fairhope, Baldwin County, Alabama. I work as a waitress and often work late and unusual hours and during the time while he is waiting for me, he drinks and gets mean and when I return home he threatens me and physically harms me by twisting my arm, striking and hitting me. My husband has committed actual violence on my person and I fear for the danger to my life and health because when my husband is drunk he is unable to control his temper and he strikes, hits, beats and twists my arm and threatens to harm me bodily.

MARCELLA JOHNSON, first being duly sworn, disposes and says:

My name is Marcella Johnson and I am the daughter of Marcella H. Gooden who is the complainant in the case and I live in Fairhope, Baldwin County, Alabama. My mother has been married to Broward B. Gooden twice and she received a divorce from her husband early last year but her husband promised to do better and she remarried him last year. I know my stepfather Broward B. Gooden drinks and my mother works as a waitress ofter late at night and I have seen black/blue marks on my mothers body. I know that my stepfather has threatened my mother and that she fears to live with him any longer because when he drinks, he is vital.

Your complainant Marcella H. Gooden respectfully represents and shows unto your Honor:

- 1. That complainant is over the age of twenty-one years and is a resident citizen of said State and County, and has been a bona fide resident citizen of said State and County for more than one year next preceding the filing of this bill of complaint; that Broward B.
