This cause coming on to be heard was submitted upon Bill of Complaint, Decree Pro Confesse on _____ Answer and Waiver _____ and Testimony as noted by the Register, and upon consideration thereof, the Court is of the opinion that the Complainant is entitled to the relief prayed for in said bill.

It is therefore ordered, adjudged and decreed by the Court that the bonds of matrimony heretofore existing between the Complainant and Defendant be, and the same are hereby dissolved, and that the said

ANNIE CHARLES GAMMAGE is forever divorced from the said GILMER D. GAMMAGE for and on account of CRUELTY.

It is further ordered, adjudged and decreed that the written agreement entered into between the Complainant and Respondent touching the distribution of personal property and the settlement of current indebtedness is hereby ratified and approved and the parties shall abide thereby. The Complainant is further given the right to resume her former name, Annie Charles Stubblefield.

It is further ordered, adjudged and decreed that neither party to this suit shall again marry except to each other until sixty days after the rendition of this decree, and that if appeal is taken within sixty days, neither party shall again marry except to each other during the pendency of said appeal.

It is further ordered that the Complainant and Respondent be, and they are hereby permitted to again contract marriage upon payment of the cost of this suit.

It is further ordered that Gilmmer D. Gammage the Respondent pay the cost herein to be taxed, for which executed may issue.

My name is Annie Charles Gammage and the Respondent's name is Gilmer D. Gammage. We are both over the age of twenty-one years and bona fide residents of Baldwin County, Alabama, and have been for more than one year next preceding the filing of this Bill of Complaint. We were married at Lucedale, Mississippi on June 9, 1954 and lived together as husband and wife until March 11, 1955.

On March 11, 1955 the Respondent cursed, abused and did commit actual violence upon my person, which I believe did endanger my life and health. The Respondent has on other occasions abused and done actual violence to me. I am afraid that if we continue to live together, the Respondent will do violence such as will injure me permanently or cause death.

My name is Melba Ann Stubblefield. I am sixteen years of age and am a daughter of the Complainant by a former marriage. On the night of March 11, 1955 I was in the home of the Complainant and the Respondent. The Respondent cursed and hit the Complainant. He hit her on the head and about the body several times. There were bruises on the body of the Complainant which were a result of his cruelty.

FIRST:

That your Complainant and the Respondent are over the age of twenty-one years, and are both resident citizens of Baldwin County, Alabama, residing at Fairhope, and that they have been such residents for more than two years last past.

SECOND:

That your Complainant and the Respondent were married on heretofore, to-wit, June 9, 1954, and lived together as man and wife until March 11, 1955, when, on account of the matters hereinafter complained of, your Complainant was compelled to live separate and apart from the Respondent. Your Complainant further avers that the Complainant and the Respondent were lawfully married in Lucedale, Mississippi on the above stated date and that there are no children of the marriage.

Your Complainant avers and charges that the said Respondent did on or about the 11th day of March, 1955, and at times prior thereto, did assault, beat, hit and strike Complainant; that said Respondent has committed actual violence on her person attended with danger to her health and life; Complainant avers and charges that Respondent has made numerous threats or doing her physical harm and from his manner and conduct toward her, she is reasonably convinced that he will commit such violence upon her person, attended with danger to her life or health.

PRAYER FOR PROCESS AND RELIEF:

The premises considered, your Complainant prays that the above named Gilbert D. Gammage be made a party Defendant to this cause by the usual writ or process of this Honorable Court requiring him to appear and plead, answer or demur within the time and under the penalties prescribed by the rules of this Court and the Statutes in such cases made and provided; that upon a final hearing of this cause that your Honor will grant unto the Complainant an absolute divorce from said Respondent and will decree that the parties be allowed to remarry if they see fit. Should your Complainant be mistaken in the relief prayed for, that there be granted to her such other, further and different relief to which she may be entitled and as in duty bound she will ever pray.

STIPULATION

It is stipulated and agreed by and between the parties hereto as a property division in lieu of alimony, that Gilmer D. That the Complainant, Annie Charles Gammage, has employed Ernest M. Bailey as her Solicitor of Record to prosecute the cause of action and she is unable to pay him a reasonable Solicitor's fee for his services in the matter. That Gilmer D. Gammage agrees to pay the reasonable Solicitor's fee.

That the parties shall entirely and completely separate as man and wife, live separate and apart, and neither party hereafter shall in any way harass, threaten, intimidate, or otherwise act in any way so as to embarrass or humiliate the other party.
