He then came to Foley and to my house late at night and threatened to kill me if I went to his folks or wrote to him or them again.

My name is Mrs. C. L. Westbrook. Mary Lou Schunning is my younger sister. She has been living in the same house with me since Clarence Schuning left Foley. I rember quite well the night that Clarence came to the House. It was on Wednesday night after new years day. He came to the door about 11:30 and wanted to see Mary Lou but wouldn't come in. I woke Mary Lou and told her that Clarence was out side. I thought she was going to pass out she was so afraid. I went back to the door and told him she would be out in a minute and asked him in again. He refused and I could tell he had been drinking. Mary Lou would not go to the door without me. I went and got my husband up too and Mary Lou then went to the door. Clarence started cussing her and threatening to kill her and I believe if I and my husband had not been there that he would have tried to kill her. My husband run him off by calling the cops.
