Your Complainant, Louis B. Libby, respectfully represents unto Your Honor and this Honorable Court as follows:

1.

That your Complainant is a bona fide resident citizen of Baldwin County, Alabama and over twenty-one years of age; that your Respondent is a bona fide resident citizen of Baldwin County, Alabama and is eighteen years of age.

2.

That your Complainant and the Respondent married at Springhill, Alabama, on August 11, 1958 and lived together as husband and wife in Baldwin County, Alabama, until on to-wit: January 9, 1959.

3.

That on to-wit, January 9, 1959, Respondent and Complainant has an argument and that the Respondent hit him about his body, kicked him and hit him several times in the back and at that time the Complainant had within the last few days been severely burned and was unable to defend himself and was caused great and severe pain; from the conduct of the Respondent, the Complainant was given every reasonable apprehension to believe and he does

believe that if he continued to live with the Respondent she would do actual violence to his person which would necessarily endanger his life and health.

Your Complainant further says that the Respondent has repeatedly started arguments and fights with him during their married life and he says that he cannot live with the Respondent with any degree of comfort or safety.

4.

There were no children born to the marriage and there is no property settlement to be made.

WHEREFORE, the premises considered, your Complainant prays that Your Honor will by proper process make the said Sonia Libby party Respondent to this bill of complaint requiring her to plead, answer or demur to the same within the time and under the penalties prescribed by law and the practice of this Honorable Court.

Your Complainant further prays that upon a final hearing hereof, Your Honor will enter a decree forever barring the bonds of matrimony existing between your Complainant and the Respondent; your Complainant prays for such other, further, different, or general relief as he may be in equity and good conscience entitled to receive.
