The premises considered, the Complainant prays that the above named Chester Arthur Pickering be made a party defendant to this cause all by the usual writ or process of this Honorable Court requiring him to appear and plead, answer or demur within the time and under thepenalties prescribed by the rules of this Court and the Statutes in such cases made and provided. That upon the final hearing of this cause, Your Honor will grant unto Complainant an absolute divorce from Respondent and will decree that the parties be allowed to remarry if they see fit. Your Complainant further prays for such other, further and different relief to which she may be entitled and as in duty bound she will ever pray.
