FIRST: That Complainant, ELEANOR KIHANO, is over the age of sixteen years and is a resident of Baldwin County, Alabama, and has been a bona fide resident of said State for more than two years next preceding the filing of this Bill of Complaint; that respondent's address is: Co. SECOND: That your complainant and respondent were lawfully married on or about, to-wit: November 20, 1954, at Lucedale, Mississippi.

THIRD: Your complainant avers and charges that the said respondent did on or about the 7th day of December, 1954, commit an assult upon your complainant by hitting, beating and striking said complainant; that said respondent has committed actual violence on your complainant attended with danger to her life and health; that since assult she has not lived with said respondent and as a result of said assult.

FOURTH: Your complainant further avers that no children were born to the union of said complainant and respondent; and further, that there is no property settlement to be had between the parties.
