The unknown heirs and devisees of Jimmie Keys, Deceased, and the unknown heirs and devisees of George R. Ruffin, Deceased, are, if living, over twenty-one years of age, but their places of residence and post office addresses are unknown and cannot be ascertained after reasonable efforts and the making of diligent inquiry to ascertain the facts with regard thereto.

The said Bill of Complaint has been filed for the purpose of establishing the title of the said Complainant to all of the said lands, for the purpose of quieting her title thereto and to clear up all doubts and disputes concerning the title to the said

property.

Complainant claims the absolute fee simple title to all of the said lands under, from, by and through the following conveyances:

will be taken against them, testimony will be thereafter taken and the said cause submitted for a final decree quieting Complainant's title to the said lands.

This cause coming on to be heard on this date is submitted for a final decree on behalf of the complainant upon the original, verified Bill of Complaint; Order designating newspaper in which Notice of Pendency of Bill of Complaint shall be published; Notice of Pendency of Bill of Complaint; Proof of publication of notice of Pendency of Bill of Complaint; Register's Certificate as to service; Motion for leave to amend and order allowing amendment; Motion for decree pro confesso; Decree pro confesso; Motion of complainant for an order or decree setting cause for hearing, appointed a guardian ad litem to represent unknown minors and persons of unsound mind interested in this proceeding, and an attorney to represent any unknown parties interested in this proceeding who may be in the Military Service of the United States; Decree dated August 23, 1956, setting this cause for hearing on August 24, 1956, appointing Wilson Hayes as guardian ad litem to represent any unknown minor or person of unsound mind interested in this proceeding, and as attorney to represent any person interested in this proceeding who may be in the Military Service of the United States, and ordering that the testimony of the witnesses for the complainant be taken in open court and transcribed in the manner provided by Equity Rule No. 56 as amended; Notice of appointment of guardian ad litem and attorney to represent parties in the Military Service, and acceptance of such appointment; Answer of guardian ad litem and attorney for unknown parties interested in this proceeding who may be in the Military Service of the United States; and the testimony of Orrie Smith and Isaac Crandal, witnesses for the complainant, taken in open court on August 24,

1956, and the Exhibits to the testimony of the witnesses, all of which has been noted by the Register; upon consideration of all of which it appears to the court that all persons, firms or corporations named in the Bill of Complaint filed in this cause have permitted a decree pro confesso to be taken against them; that the allegations of the said Bill of Complaint are true; and that the Complainant is entitled to a decree quieting title to the lands described in the said bill of complaint, upon consideration of all of which it is, therefore, ORDERED, ADJUDGED AND DECREED by the court as follows:

1. That the complainant, Lillie Ruffin, is the law-ful owner in fee simple, of the following described lands situated in Baldwin County, Alabama, to-wit:

Begin at the Northeast corner of the Southwest Quarter of Section 15, Township 5 South, Range 2 East, and run thence West 1320 feet to a corner; thence South 496 feet to a corner; thence East 1320 feet to a corner; thence North 496 feet to the point or place of beginning, containing 15 acres, more or less,

That the absolute fee simple title to the said lands and each and every part thereof and all interest therein is in the said complainant, Lillie Ruffin, free and clear of and from the claim or claims of all persons, firms or corporations, claiming any title to, interest in, lien or encumbrance on the said lands, or any part thereof, or any interest therein; that the said complainant has and is hereby given judgment against the said land and against all persons, firms or corporations claiming any title to, interest in, lien or encumbrance on the said lands or any part thereof.

2. The complainant's title to the said lands is hereby quieted against the unknown heirs and devisees of Jimmie Keys, Deceased; the unknown heirs and devisees of George R. Ruffir Deceased, and against any and all persons, firms or corporations claiming any title to, interest in, lien or encumbrance on the said lands, or any part thereof, and all such claims are hereby adjudged and decreed to be invalid, groundless and of no effect.

- 3. The Register of this Court shall, within thirty days from the rendition of this decree, file a certified copy hereof in the Office of the Judge of Probate of Baldwin County, Alabama, for record therein, and tax the cost of such recording as a part of this proceeding.
- 4. The Judge of Probate of Baldwin County, Alabama, shall record the said certified copy of this decree in the same book and manner in which deeds are recorded, and shall index the same in the Direct Indexes in the names of Jimmie Keys and George R. Ruffin and shall index the same in the Indirect or Reverse Index of said records in the name of Lillie Ruffin.
- 5. The title hereby adjudged and decreed to be in said Complainant, Lillie Ruffin, shall inure to the benefit of all persons who derive title to the said lands, or any part thereof, or any interest therein, from or through the said complainant, and such title or interest shall be at all times treated and considered as though it had been established in favor or the person or persons so procuring or deriving title from the said complainant.

- Q. Lillie lives with you at this time?
- A. Yes sir.
- Q. She has lived with you since approximately right after her husband died?
- A. Yes sir, same day.
- Q. You are familiar with her affairs?
- A. Yes sir.
- Q. I believe you stated that the abstract was made and you had me to examine it, or Lillie did, and you too?
- A. Yes sir.
- Q. All of the information relative to the title and ownership shown by the abstract is set out in this complaint?
- A. Yes sir.
- Q. You are familiar with this complaint?
- A. Yes sir.
- Q. And the facts therein set forth are true and correct?
- A. Yes sîr.
- Q. During the 10 years you were there and up to the date of George Ruffin's death, did he claim to own the property?

- A. All of my life.
- Q. Did you know George Ruffin during his life time?

- A. Yes sir, he and I used to work together.
- Q. He died in 1935?
- A. No sir, 1955 last yeat.
- Q. And you know that he farmed it himself?
- A. Yes sir.
- Q. And he had possession of it?
- A. Yes sir.
- Q. He was in the notorious and adverse possession, and peaceable possession of it during his life time?
- A. That's right.
- Q. And do you know of any heirs of George Ruffin?
- A. No sir, not one.
- Q. In the community where he lived is he reputed not to have had any heirs other than Lillie?
- A. So far as I know of.
- Q. What kind of fence is that on the land?
- A. It is a good fence, because it/surrounded by other farms, practically on every side.
