DECREE REMOVING DISABILITIES OF NON-AGE

This cause coming on to be heard on this date is submitted for a final decree upon the sworn petition of Cecil Ray

Trawick, notices and affidavits as shown by the note of submission and, upon consideration thereof, the court of the opinion and finds that all of the allegations of the petition are true; that the said Cecil Ray Trawick is a minor over the age of eighteen years and under the age of twenty-one years; that he is a resident of Baldwin County, Alabama, and is for his age a person of mature judgment, of sober and industrious habits, and is competent and capable in every way of handling his own affairs and is the owner of property in Baldwin County, Alabama; the court further finds that it is to the best interest of said minor to grant the prayer of his petition, it is, therefore, ORDERED, ADJUDGED AND DECREED by the court as follows:

- 1. The said Cecil Ray Trawick be and he is hereby relieved from the disabilities of non-age and is now invested with the right to sue and be sued, contract, to buy, sell and convey real estate, and in general to do and perform all acts which such minor could lawfully do if he were twenty-one years of age.
- 2. That the said Cecil Ray Trawick file a certified copy of this decree in the office of the Judge of Probate of Baldwin County, Alabama, and in each of the counties in which said minor shall hereafter reside and in the office of the Judge of Probate in each county in the state where said minor shall do any business or make any contracts.
- 3. That the Petitioner pay the costs of these proceedings to be taxed by the Register, for which execution may issue.
