Your Complainant, Helen Perry, respectfully represents unto the court and your Honor as follows:

1. Your Complainant is over the age of twenty-one years and is a resident of Baldwin County, Alabama, and has been a bona fide resident citizen of the State of Alabama for more than one year next preceding the filing of this Bill of Complaint, but she is presently living in Columbus, Georgia. That the Respondent, James Perry, is over the age of twenty-one years and is a resident of Mobile County, Alabama.

2. Your Complainant and the Respondent were lawfully married on or about to-wit, February 15, 1941, in Pensacola, Florida, and lived together as man and wife until the month of September, 1952.

3. There was born to this marriage the following children: William Perry, a son ~~nine~~<sup>Seven</sup> years of age and Yvonne Perry, a daughter ~~nine~~<sup>Seven</sup> years of age. The said children are now in the care, custody and control of your Complainant and she alleges that she is a fit and proper person to have the care, custody and control of said minor children.

4. Your Complainant avers and charges that the said Respondent did on to-wit, September 9, 1952, commit actual violence on her person attended with danger to her health and life; Complainant avers and charges that Respondent has made numerous threats of doing her physical harm and from his manner and conduct toward her she is reasonably convinced that he will commit an actual violence upon her person attended with danger to her life and health if she continues to live with him.

5. Your Complainant further avers and charges that the Respondent did during the month of September, 1952, voluntarily abandon the bed and board of your Complainant, since which time Complainant and Respondent have not lived together nor in any way recognized each other as husband and wife.

6. Your Complainant avers that it has become necessary for her to employ an attorney to represent her in this cause and that she is without funds to pay her said attorney for services rendered and to be rendered by him in this cause.


7. Your Complainant avers that she and the Respondent are joint owners or tenants in common of the following described property situated in Baldwin County, Alabama, to-wit:

From the Southwest corner of Section 20, Township 5 South, Range 2 East, run North 516.8 feet to a point; run thence East 660 feet to a point; run thence North 330 feet to the point or place of beginning; run thence North 330 feet; run thence East 660 feet; run thence South 330 feet; run thence West 660 feet to the point or place of beginning, containing 5 acres, more or less.

Your Complainant further avers that the above described property was conveyed to your Complainant and the Respondent by her father and mother, Lloyd Thomas and Louise Thomas, his wife,

by deed dated March 15, 1948, and recorded in Deed Book 128 N. S. at page 483-4, Baldwin County, Alabama Records. Your Complainant further alleges that she and the Respondent through their joint efforts constructed a dwelling house on the above described property intending it to be their home.

The premises considered, your Complainant makes the said James Perry a party respondent to this Bill of Complaint and in order that your Complainant may have the relief prayed for herein, may it please the court to cause the State's Writ of Subpoena to be issued, directed to the said James Perry, commanding him to plead, answer or demur to this Bill of Complaint, within the time required by law; and that upon a final hearing of this cause, your Honor will make and enter a decree divorcing your Complainant from the said Respondent, awarding the care, custody and control of the said minor children to your Complainant, will fix a monthly sum to be paid to your Complainant by the Respondent for alimony and order that the Respondent pay said monthly sum, will decree that the Respondent's interest in the above described property be vested in your Complainant as permanent alimony, fix an amount to be paid to your Complainant's attorney for his services rendered in this cause and order that this sum be paid by the said Respondent and that your Honor will grant such other, further and different relief as may seem just and proper, the premises considered.

TESTIMONY TAKEN IN CHAMBERS, BEFORE HON. HUBERT M. HALL, JUDGE  
OF THE 28TH JUDICIAL CIRCUIT OF ALABAMA:

HON. JAMES R. OWEN, Solicitor for Complainant.

HELEN PERRY, THE COMPLAINANT, BEING FIRST DULY SWORN, TESTIFIED:

Examination by Mr. Owen.

Q. State your name to the Court?

A. Helen Perry.

Q. Where do you live?

A. Daphne, Alabama.

Q. Are you over the age of 21 years?

A. Yes sir.

Q. How long have you been a resident of Baldwin County, Alabama?

A. Life time.

Q. How old is the Respondent, James Perry?

A. 36.

Q. Where does he live?

A. Mobile.

Q. When were you and James Perry married?

A. February 15, 1941.

Q. Where?

A. Pensacola, Florida.

Q. How long did you all live together as man and wife?

A. Until September, 1952.

Q. Did you all have any children born of this marriage?

- A. Yes sir.
- Q. Who are those children?
- A. William Perry and Yvonne Perry.
- Q. How old are they?
- A. Seven.
- Q. They are twin children?
- A. Right.
- Q. Where are those children now?
- A. With me in my home.
- Q. Have you had the care, custody and control of these children since September of 1952?
- A. Yes I have.
- Q. Are you a fit and proper person to have the care, custody and control of these minor children?
- A. Well I think so.
- Q. Since you and your husband separated in September of 1952, has he contributed any money for the support and maintenance of you and your two minor children?
- A. One \$20.00.
- Q. One \$20.00 since September of 1952?
- A. That's right.
- Q. What does your husband do?
- A. He operates a tavern.
- Q. Where?
- A. In Mobile.
- Q. Does he operate anything else in conjunction with that Tavern? A Restaurant or anything?
- A. No. He has a part time program on W.M.O.S. Radio Station.
- Q. In addition to his operation of this tavern, is that right?
- A. That is right.
- Q. Can you give the Court any idea or opinion of his monthly earnings from the operation of this tavern and this radio program?
- A. Well I don't know definitely, but I would say approximately

\$400.00 to \$500.00 a month, or more.

Q. Per month?

A. Yes sir.

Q. What were the circumstances surrounding your separation in September of 1952?

A. False accusations for one thing.

Q. What else?

A. Cruelty.

Q. What did this cruelty consist of?

A. Knife inflicted wounds.

Q. When did that happen?

A. On September 9, 1952.

Q. What sort of wounds did he inflict on you with this knife?

A. A deep stab wound in the left ilium - right here - my hip bone, and a deep laceration across my left shoulder.

Q. Did you see a Doctor on those occasions?

A. I was in the hospital.

Q. Were there any stitches taken for those cuts and stabs?

A. I imagine between 25 and 30.

Q. How long were you under a Doctor's care?

A. Well for about a week.

Q. And have you and James lived together since that time as husband and wife?

A. No .

Q. At that time did you inflict any kind of physical injury on him?

A. No, I was in no position.

Q. Has it become necessary for you to employ an Attorney in this case to represent you?

A. Yes sir.

Q. Do you have any money with which to pay your Attorney for services rendered in this cause?

A. No, not now.

Q. Look at this complaint and look at the property described

in paragraph 7 and I will ask you if you and your husband  
are joint owners or tenants in common of that property?

A. Yes sir, we are joint owners.

Q. Did you - where did you all get that property?

A. My father gave it to me - gave it to us.

Q. Gave it to both of you?

A. Yes sir.

Q. Was there a dwelling house on this property at the time  
he gave it to you?

A. No.

Q. Is there now a dwelling house on it?

A. Yes sir.

Q. Who built that house?

A. My father.

Q. Who furnished the materials?

A. We did.

Q. We @ you mean you and your husband?

A. That's right.

Q. In your best judgment, how much did you pay on the building  
materials which went in the construction of this house?

A. I would say approximately \$1500.00.

Q. Who paid that?

A. I paid the biggest portion, because he was in and out - on  
his way out - this was before the cutting.

Q. How much did you pay , in your best judgment?

A. I imagine I paid two-thirds, or approximately \$1,000.

Q. Who paid for the labor which went into this construction  
of this house?

A. Nobody.

Q. Was there any charge for the labor?

A. No.

Q. Who actually performed this labor for you.

A. My father.

Q. Did any one help your father?

A. Yes.

Q. Who?

A. George Jones.

Q. Is he here today?

A. Yes sir.

Q. In your opinion, what is the value of this house and lot where you are presently living -- That is, the house situated on the property described in the complaint?

A. I would say between \$3,000.00 and \$5,000. I am not living in this house.
