

Should your Complainant be mistaken in the relief prayed for, that there be granted to him such other, further and different relief to which he may be entitled and as in duty bound he will ever pray.

TESTIMONY TAKEN IN CHAMBERS, BEFORE HON. HUBERT M. HALL, JUDGE OF
THE 28TH JUDICIAL CIRCUIT OF ALABAMA:

MR. WOODROW BRYANT, THE COMPLAINANT, BEING FIRST DULY SWEORN,
TESTIFIED:

Direct Examination by Mr. Chason.

Q. Is this Mr. Woodrow Bryant?

A. Yes sir.

Q. Mr. Bryant, are you the husband of Evelyn D. Bryant?

A. Yes sir.

Q. Are you both over the age of 21 years?

A. Yes sir.

Q. You are both resident citizens of Baldwin County?

A. Yes sir, that's right.

Q. Both reside near Bay Minette?

A. Yes sir.

Q. Have both of you been a resident citizen of this County all
of your life?

A. Yes.

Q. How long have you known her to be a resident citizen of Baldwin
County?

A. All of my life, except when she was away.

Q/ When did you marry Evelyn D. Bryant?

A. On the 15th day of February, 1956?

Q. Now did you live with her as man and wife until Saturday,
February 25, 1956?

A. Yes sir.

Q. On that Saturday night had she been out some where with your truck?

A. Yes sir.

Q. Did she come in and bring you your keys?

A. Yes sir

Q. What time of the night was that?

A. 11:00 or 11:30 .

Q. Did she proceed to go out again?

A. She never stopped.

Q. Did she tell you she was going out?

A. Yes sir.

Q. Where did she tell you she was going?

A. Back to her children with Charlick Fretwell.

Q. Did you see her leave the house?

A. Yes sir.

Q. Did you walk to the door as she left?

A. Yes sir.

Q. Did you see her going down the lane?

A. Yes sir.

Q. Was it a moon-light night?

A. Yes sir, bright as day.

Q. Could you see Mr. Fretwell out there?

A. No sir.

Q. Soon thereafter did you hear the truck start up?

A. Yes sir.

Q. Does Mr. Fretwell have a truck?

A. Yes sir.

Q. Since that time has she been back to live with you?

A. No sir, today is the first time I have seen her.

Q. You have not lived together as man and wife since February 25, 1956?

A. No sir.

Q. Did she tell you this morning that she committed an act

of adultery with Mr. Charlick Fretwell on that Saturday night, February 25th?

A. I heard her make that statement in your office this morning.

Q. You have not had any further acts of intercourse with her since you learned that she had gone off with Mr. Fretwell?

A. No sir, I've not seen her until today.

Q. Were you at one time married to Mrs. Bryant?

A. For 15 years.

Q. You all have been divorced?

A. Yes sir

Q. She is the wife now of Mr. Woodrow Bryant?

A. Yes sir.

Q. On Saturday night, February 25, 1956, did you go to her house to get her in a truck?

A. I went to the road.

Q. Out in front of the house?

A. Yes sir.

Q. Did she leave there with you?

A. Yes sir.

Q. Did you all leave there and go to another house where you are living?

A. Yes sir.

Q. On the night of February 25, 1956, did she have an act of intercourse with you?

A. She did.
