This cause coming on to be heard was submitted upon Bill of Complaint, ~~Decree Pro Confesso et Concessione~~ answer of defendant and Testimony as noted by the Register, and upon consideration thereof, the Court is of the opinion that the Complainant is entitled to the relief prayed for in said bill.

It is therefore ordered, adjudged and decreed by the Court that the bonds of matrimony heretofore existing between the Complainant and Defendant be, and the same are hereby dissolved, and that the said Wanda Mae Wilson is forever divorced from the said James L. Wilson for and on account of Habitual Drunkenness and Cruelty

It is further ordered, adjudged and decreed that neither party to this suit shall again marry except to each other until sixty days after the rendition of this decree, and that if appeal is taken within sixty days, neither party shall again marry except to each other during the pendency of said appeal.

It is further ordered that the Complainant and Respondent be, and they are hereby permitted to again contract marriage upon payment of the cost of this suit.

It is further ordered that James L. Wilson the defendant pay the cost herein to be taxed, for which executed may issue.

TO THE HONORABLE HUBERT M. HALL, JUDGE OF THE CIRCUIT COURT OF BALDWIN COUNTY, ALABAMA, SITTING IN EQUITY:

And now comes your complainant, Wanda Mae Wilson, and humbly complaining against James L. Wilson, defendant, respectfully shows unto your Honor:

First: That your complainant and the said James L. Wilson are each over the age of twenty-one years and are residents of Baldwin County, Alabama, where they resided at the time of their marriage and have resided continuously since.


SECOND: That your complainant and the said James L. Wilson are husband and wife, having intermarried at Bay Minette, Alabama, September 26, 1943, and they lived together as husband and wife until March 23, 1956.

THIRD: That the defendant at the time of their marriage was a sober and industrious man, but since their marriage he has become and is an habitual drunkard; that he is a man of violent and ungovernable temper and frequently becomes enraged without

just cause or legal excuse and curses and abuses this complainant; that on, to-wit: the 23rd day of March, 1956, the defendant in a drunken condition cursed and abused this complainant and severely beat her with his fist and bruised and lacerated her body and threatened to kill her and that because of his habitual drunkenness and because of his cruelty and threats, complainant left him and she has reasonable apprehension to believe that should she continue to live with him he would do her bodily harm, attendant with danger to her life or health; that she only prevented his exercising his threats to kill her on March 23, 1956 by fleeing from him and leaving home and she fears to return to him.

WHEREFORE your complainant prays that this Honorable Court will take the jurisdiction of the cause made by this bill of complaint and make the said James L. Wilson, party defendant hereto, and by appropriate process require him to plead, answer or demur to the same within the time and under the pains and penalties prescribed by law and the practice of this Honorable Court.

Complainant further prays that upon the final hearing of this cause this Honorable Court will make and enter a decree forever dissolving the bonds of matrimony existing between this complainant and the said defendant, and complainant prays for such other, further or different relief as in equity and good conscience she shall be entitled to receive in the premises.
