TODD, is over the age of twenty-one years and is a resident of Bay Minette, Baldwin County, Alabama. The respondent and I were married at Hartwell, Georgia, on the 5th day of July, 1950. We have lived in Baldwin County for the last past years. About two or three years ago, my husband began to mistreat, threaten and abuse me. On several occasions, his treatment of me became so violent as to give me reasonable cause to believe that, if I continued to live with him as his wife, he would commit antual physical violence on my person which would necessarily endanger my life or health, and because Oftthat fear I left him, but because of the children I would go back to him. Finally, his abuse became worse and on or about the 10th day of April, I became convinced that it would be dangerous to my life or health if I continued to live with him as his wife, and I left him at that time and have not since that time returned to live with him as his wife. We have two children, JANIE DIANE TODD, age seven years, and WILLIAM CARLTON TODD, age two years. I feel that I am the proper person to have the care, cusbody and control of these children. We have arranged between ourselves for the support of the children and for a division of our property." Further deponent says not.
