That your Complainant is now over 18 years of age and is a bona fide resident of Baldwin County, Alabama, and the Respondent, ANDREW L. LIGHT, is 21 years of age and is presently residing in Princess Anne, County, Va.

That your Complainant and the Respondent went through a marriage ceremony at Bay Minette, Alabama, on October 3, 1958.

That no consent was given by either of the Petitioner's parents.

That shortly after going through the ceremony the Respondent left the Complainant, never to return and the Complainant was forced to return to live with her people.

There are no children born of fruits of this marriage and there is no property involved.

PRAYER

WHEREFORE the premises considered your Petitioner prays that your Honor will by proper procedure make the said ANDREW L. LIGHT part Respondent to this Bill of Complaint, requiring him to plead, answer

demur to the same within the time and under the penalties prescribed by law and the practice of this Honorable Court.

The Complainant further prays that upon final hearing hereof your Honor will grant to her a decree annuling and declaring void the ceremony entered into as alleged herein, and your Complainant prays for such other, further, different, or general relief that she may, in Equity and

good conscience be entitled to receive.
