To the Honorable H. M. Hall, Judge of the Circuit Court of Baldwin County, Alabama, Sitting in Equity.

Comes your Complainant, ILENE WOOTEN STYRON, and respectfully shows unto this Honorable Court as follows:

- 1. That she is over the age of twenty-one years and that she is a bona fide resident citizen of Baldwin County, Alabama; that Raymond C. Styron, the Respondent in this cause, is over the age of twenty-one years and a resident citizen of Baldwin County, Alabama.
- 2. That on, to-wit: the 26th day of September, 1958 your Complainant and Respondent were intermarried at Mobile, Mobile County, Alabama, and that your Complainant and the Respondent are still lawfully married.
- 3. That there has been born of said marriage two minor children, whose names and ages are respectively: Mary Styron, age nine; and Judy Styron, age three months. That said children are temporarily in the custody of the parents of the Respondent.
- 4. Your Complainant further avers that at diverse times and places, since 26 September 1958, the Respondent has committed adultery by unlawful cohabitation with an adult woman, whose name to your Complainant is not known;
- 5. Your complainant further avers and charges that on the 19th day of June, 1959, the Respondent, without cause or justification, using his hands and closed fists and feet, struck, kicked and beat your complainant about the face and body a number of times, inflicting bruises and injuries upon the body of your complainant, attended with great danger to her health and life; and from his manner and conduct toward her, she is reasonably

convinced that he will commit further actual physical violence upon her person attended with danger to her health and life; that on, to-wit: the 19th day of June, 1959, she separated from and abandoned the said Respondent, and is now living separate and apart from him.

- 6. Your complainant further avers that on the 19th day of June, 1959, your Complainant went to the home of the parents of the said Respondent and was denied custody of the children by the said Respondent; that your complainant is a fit and proper person to have control of the minor children of this marriage, and that it would be to their interest to be in the care, custody and control of your Complainant.
- 7. Your Complainant further avers that Raymond C. Styron is gainfully employed, and is informed and believes, and on information and belief, alleges that he receives Seventy-two (\$72.00) Dollars per week for his work and labor.

The premises considered, your Complainant prays that the Respondent be made a party respondent to this Bill of Complaint by the usual process of this Honorable Court, and the statutes in such cases made and provided requiring him to plead, answer or demur, within the time and within the manner provided by law; and that on the final hearing of this cause that your Honor will enter a decree divorcing your Complainant from the said Respondent, granting both parties the right to re-marry, awarding the custody and control of said minor children unto your complainant, and decreeing that the Respondant shall pay the sum of \$100.00 per month for the support and maintenance of said children.

Your Complainant further prays that your Honor will decreed that Respondent pay the Complainant's attorneys' fee for this action in the amount of \$250.00. Your Complainant further prays for such other, and further relief to which she may be entitled and as in duty bound she will ever pray.
