I married William Wilson, the defendant in this case in the Court House in the City of Bay Minette, Baldwin County, Alabama, on the 18th day of April, 1959, We lived together as husband and wife in the town of Silverhill, Alabama, until the 3rd day of June, 1959. On that day the defendant came home from his work and was/ARd that he hit me with his fist in my mouth and brock one of my front teeth. He works at night with the Alabama Wood Preserving Company in Roberts dale and get home about 7 o'clock in the morning. He ordered me out of the house and told me to get my things and go back home to my parents in Loxley and that if I ever came back there he would kill me. While I was getting my things together he hit me again in the eye and black my eye, which stayed that way for several days. I did not do anything to him to provoke him and tried tomakeour marriage work, but from his conduct and treatment of me for the short time that we were married I was forced to leave him for fear of my life and health and moved back with my parents in Loxley, where I have remained since that date. I have reasonable grounds to believe that should I return to live with him that he would inflict grave bodily harm to my life or health.
