Barnhill and Charles Barnhill, witnesses for the complainant, taken in open court on this date, and the exhibits to the testimony of the said witnesses, all of which has been noted by the Register, at which time the said cause was taken under submission, upon consideration of all of which, it appears to the court that all persons, firms or corporations named in the bill of complaint filed in this cause have permitted a decree pro confesso to be taken against them;

ROGER F. BARNHILL, THE COMPLAINANT, BEING FIRST DULY SWORN, TESTIFIED AS FOLLOWS:

Examination by Mr. Blackburn.

- Q. What is your name, please?
- A. RogertF. Barnhill.
- Q. You are the Complainant in this case, are you not?
- A. Yes sir.
- Q. You are over the age of 21 years and a resident of Baldwin County?
- A. Yes sir.
- Q. Mr. Barnhill, the land involved in this suit, which is the E¹/₂ of Section 33, Township 4 South, Range 4 East, and the Southeast Quarter of Northwest Quarter, Section 4, Townshup 5 South, Range 4 East, who did you acquire that from?
- A. McCoy Timber Company.
- Q. That was in 1950, I believe?
- A. Yes sir.
- Q. After you acquired this property what did you first do with it?
- A. By way of possession, I fenced it and started claring it.
- Q. How soon after you got your deed did you do that?
- A. I fenced it either in '51 or '52 and started clearing in '52; it has been under fence tince then.
- Q. Been under fence since then?
- A. Yes sir.
- Q. Are you cultivating some of it?
- A. Pasture.
- Q. What did you do with the rest of it?


