Comes your Complainant, Barbara Schnatz Woerner, and respectfully represents and shows unto your Honor as follows:

- 1. That the said Barbara Schnatz Woerner is over the age of 21 years, and is a resident citizen of Baldwin County, Alabama; that the said John Woerner is over the age of 21 years and is a resident citizen of Baldwin County, Alabama.
