Kay Galloway, age about one year; that your Honor will grant to the Complainant permanent maintenance for said children in the amount of One Hundred (\$100.00)

Dollars per month and in asmuch as your Complainant is without funds it is suggested that One Hundred (\$100.00) Dollars be allowed as a reasonable Solicitor's fee to your Complainant's Solicitor for his services herein.
