At the time of the separation the Respondent became angry with me and jumped on me throwing me down and striking me about the face and head so that I became in fear of my life or health and knew that I could never live with him any more as his wife. We have not lived together since the occasion on February 20th and I know that I can never live with him anymore as his wife. There are two children born as fruits of this marriage and another child will be born on or about the last of September 1956. We have agreed that I am to have the custody of the older child, Herman Jerome Paul, age about three and I ask that a copy of our agreement be made a part of our testimony. We have also agreed that I shall have the care custody and control of the unborn child. The little girl age one year Rhonda Gayle Paul, we permitted and signed papers for the Respondents brother, Robert Paul and his wife Martha to adopt her and this has been done. I do not ask for any maintenance or support for the children. I have agreed that the Respondent have the right to visit with Herman Jerome and have the little boy to visit with the Respondent at reasonable time and occasions. We have no property to be divided.

WHEREFORE, the premises considered, your Complainant prays that your Honor will by proper procedure make the said Herman Paul, party Respondent to this bill of complaint requiring him to plead, answer or demur to the same within the time and under the penalties prescribed by law and the practice of this Honorable Court.
