I was around them quite a bit of the time, enough to know that Clara Eddins Carver treated Thomas Alvin Carvin in a very bad manner. She would slap and curse and threaten him with acts of greater physical violence. On the night of September 6, 1956, she became so wild in her actions toward him, slapping, kicking, cursing and threatening him, that he feared for his own personal safety. Thomas Alvin Carver left Clara Eddins Carver on that night and to the best of my knowledge, they have not since lived together as man and wife.
