SECOND: That your complainant and the said Doyle C. Complainant further prays that upon the final hearing of this cause this Honorable Court will make and enter a decree forever dissolving the bonds of matrimony existing between this complainant and the said defendant and complainant prays for such other, further or different relief as in equity and good conscience she shall be entitled to recieve in the premises.
