STIPULATION

It is stipulated and agreed by and between the parties hereto as a property division in lieu of alimony that the said Horace L. Bell has this day transferred to Iris Oleta Bell all his interest in a certain family Chevrolet automobile; that the transfer was made subject to an existing chattel mortgage of approximately \$220.00, payable to the American National Bank of Mobile, Alabama, which mortgage has been assumed by Iris Oleta Bell. That the parties have also agreed between themselves as follows: That the said Iris Oleta Bell has this day transferred and assigned to Horace L. Bell all her leasehold interest in certain lands and improvements of the Fairhope Single Tax Corporation of Fairhope, Alabama, and more specifically described as land in Block 23 of Magnolia Beach Addition to Fairhope and further described as Lot 14 and the East one-half of Lot 15, Blocks 23-27 of the Single Tax Corporation's unrecorded resubdivision map. This conveyance is subject to an existing mortgage to Liberty National Life Insurance Company; which mortgage Respondent hereby assumes and agrees to pay; The parties further agree that a division of personal property (household effects) shall be distributed as follows: Complainant to have (1) five piece living room suite, (1) five piece dining room suite, stove, refrigerator, washing machine, TV set, (1) four piece bedroom suite, Cedar chest, (1) set of silver and (1) set of China, (washing machine and television set are subject to installment payments, which payments Complainant agrees to assume and pay). That the parties have also agreed that the Respondent shall have an air conditioner and an outboard motor which are jointly owned by the parties, the installment payments on which Complainant does hereby assume and agree to pay.
