Sitting in Equity:

Comes now the Complainant, Bob Loe, humbly complaining of the Respondent, Mable R. Loe, in a matter of divorce, and represents and shows unto Your Honor as follows:

FIRST: That Complainant, Bob Loe, is over the age of twenty-one years and is a resident of Baldwin County, Alabama, and has been a bona fide resident of said State for more than five years next preceding the filing of this Bill of Complaint; that respondent's address is unknown to your complainant, and after a due and diligent search, complainant is unable to ascertain her place of residence or post office address; that the respondent is over the age of twenty-one years; and is a non-resident of the State of Alabama.

SECOND: That your complainant and respondent were married on January 26, 1956, at Pensacola, Florida.

THIRD: Your Complainant avers and charges that the Respondent has made numerous threats of doing him physical harm and from her manner and conduct toward him, he is reasonably convinced that she will commit an actual violence upon his person, attended with danger to his life and health; the last of such threats did occur on August 1, 1956, and as a result of said threats, Complainant and Respondent have not lived together since that time as husband and wife.

FOURTH: Your Complainant would further aver and show unto Your Honor that no children were born to the Union of the Complainant and Respondent; and further that there is no property to be settled between the Complainant and Respondent herein.

PRAYER FOR PROCESS

Wherefore the premises considered the Complainant prays that the said Mable R. Loe, be made party Respondent to this his Bill of Complaint and that a summons be issued and served upon her as required by law and the rules of this Honorable Court, and that she be required to plead, answer or demur to the within Bill of Complaint within the time and under the penalties prescribed by law and the rules of this Honorable Court.

PRAYER FOR FINAL RELIEF

The premises considered the Complainant prays that on a final hearing of this cause Your Honor will make and enter a decree forever dissolving the bonds of matrimony heretofore existing between the Complainant and Respondent, and will grant to the Complainant a full and absolute divorce from the Respondent, and that in and by virtue of the said decree the Complainant will be granted the right to again contract marriage.
