- 1. That complainant is over the age of twenty-one years and is a resident of said County and State; that ALBERT D. LAMBERT, also known as A. D. LAMBERT, is over the age of twenty-one years and is a resident of said County and State;
- 2. That your Complainant and the Respondent were lawfully married on or about, topwit: the 14th day of May, 1953, at Lucedale, Mississippi;
- 3. Your complainant avers and charges that the said respondent did, on or about the 10th day of June, 1957, curse, abuse,
  and threaten to commit an actual violence on her person; that on
  many occasions prior to that time he had committed actual violence
  on her person attended with danger to her life or health; and that
  on the said 10th day of June, because of his manner and conduct
  toward her, she became reasonably convinced that, should she continue to live with him as his wife, he would carry out his threats
  and commit an actual violence on her person which would necessarily
  endanger her life or health; and, for that reason, she was forced
  to leave the said respondent on the aforesaid 10th day of June, 1957.
- 4. That, during most of their four years of marriage, complainant has been forced to support and maintain herself and her
  child with little or no financial help from the respondent; that
