Comes your complainant, Florence Hinote, and exhibits this, her Bill of Complaint for Divorce, against John Hinote, and shows unto your Honor and unto this Honorable Court as follows:

FIRST:

That your Complainant and Respondent are both over the age of twenty-one years and are bona fide residents of Baldwin County, Alabama, your Complainant residing near Bay Minette, and your Respondent residing near Loxley, and that both your Complainant and Respondent have been residents of Baldwin County, Alabama, for many years.

SECOND:

heretofore, to-wit, May 19th, 1898, and have lived together as man and wife since that time, and until, on account of the matters hereinafter complained of, your Complainant was compelled to leave the Respondent and live separate and apart from him; that on or about the 3rd day of August, 1935, while your Complainant and Respondent were living together as man and wife in Baldwin county, Alabama, the Respondent committed actual violence on the person of your Complainant, attended with danger to life or health; that the Respondent struck your Complainant, and beat her on the head and back; that the conduct of Respondent was such that your Complainant had reason to apprehend the commission of further violence on her person, attended with danger to her life or health had she continued to reside with him.

PRAYER FOR PROCESS AND RELIEF.

THE PREMISES CONSIDERED, your complainant prays that

the above named Respondent be made party defendant to this cause by the usual process of this Henorable Court, requiring him to appear and plead, answer or demur, within the time and under the penalties prescribed by the rules of this Court and the statutes in such cases made and provided.

That upon a final hearing of this cause there be granted to your Complainant a divorce, and should your Complainant be mistaken in the relief prayed for that there should be granted to her such other, further and different relief to which she may be entitled. And as in duty bound she will ever pray.




