TO THE HONORABLE HUBERT M. HALL, JUDGE OF THE CIRCUIT COURT OF BALDWIN COUNTY, ALABAMA, SITTING IN EQUITY:

Your Complainant, Willie Baker, respectfully shows unto this Honorable Court and your Honor as follows:

That the Complainant is a resident of Baldwin County, Alabama, and has been a resident for more than one year next, preceding the filing of this his Bill of Complaint; that your Complainant is over the age of twenty-one years; that the Respondent Lizzie Baker, is over the age of twenty-one years and her address is 7351 Vincennes Avenue, Chicago, 21, Illinois.

That your Complainant and the Respondent were married at Mo-bile, Alabama, on the 11th day of August, 1943, and lived together as husband and wife until on to-wit: the 7th day of January, 1947.

That on to-wit; the 7th day of January, 1947, the Respondent voluntarily abandoned the bed and board of the Complainant, and since which time the Complainant and Respondent have not lived together nor any way recognized each other as husband and wife.
