It is further ordered that the Complainant and Respondent be, and they are hereby permitted to again contract marriage upon payment of the cost of this suit.

It is further ordered that Peter A. Frauenhoffer the Respondent pay the cost herein to be taxed, for which executed may issue.

Testimony of Doris Janell Frauenhoffer:

My name is Doris Janell Frauenhoffer. I am over the age of twenty-one years and a bona fide resident citizen of Baldwin County, Alabama, residing at Elberta, Alabama. Peter A. Frauenhoffer is over the age of twenty-one years, and is also a bona fide resident citizen of Baldwin County, Alabama, having resided therein for all of his life. We were married on March 4, 1958 and lived together until May of 1958, at which time I could no longer live with him because of his abuse. He, on several occasions, struck me with his fists and committed other actual violence on my persons attended with danger to my life and health, and he continually threatened me with other and further violence, so that I was apprehensive at all times of being beaten and abused. There are no children of my marriage to Peter A. Frauenhoffer.

Testimony of J. B. McCraney

My name is J. B. McCraney. I am over the age of twenty-one years and a resident of Elberta, Alabama.

I am personally acquainted with Doris Janell Frauenhoffer and Peter A. Frauenhoffer, who were married on March 4, 1958, and who lived together as husband and wife until May of 1958. During the time of their marriage I have heard him threaten to do her actual physical bodily harm, and have known of him beating her and committing acts of violence on her person so that she was visibly bruised. I believe that she would be reasonable in fearing to live with him, and believe that he would have severely injured her had she continued to do so. Both of them are over the age of twenty-one years of age, and have no children of this marriage. Also both are residents of Baldwin County, Alabama.

to her life or health.

4. Complainant further shows that there were no children  
of her marriage with the Respondent.

PRAYER FOR PROCESS AND RELIEF

THE PREMISES CONSIDERED, your Complainant prays that Peter  
A. Frauenhoffer be made a party defendant of this cause by the  
usual process of his Honorable Court, requiring him to plead,



answer or demue within the time and under the penalties prescribed by the rules of this Court and the Statutes in such cases made and provided; that upon a final hearing of this case that she be granted a divorce from the said Respondent. Should your Complainant be mistaken in the relief prayed for, that she be granted such other, further, different and general relief to which she may be entitled and as in duty bound she will ever pray.
