It is futher ordered that the Complainant and Respondent be, and they are hereby permitted to again contract marriage upon payment of the cost of this suit.

It is further ordered that Bobby Wilson the complainant pay the cost herein to be taxed, for which executed may issue.

She is in my custody and care and has been since November 4, 1957. Virginia Jean and I resided in Baldwin County from the date of our marriage until she abandoned me. On September 25, 1957 she abandoned him without just cause or reasonable excuse and they have not lived together as husband and wife since that date. And now comes your complainant, Bobby Wilson, and humbly complaining against Virginia Jean Wilson, defendant, respectfully shows unto your Honor:

First: That your complainant is over the age of twenty-one years, that the defendant, Virginia Jean Wilson, is seventeen years of age, and that they are residents of Baldwin County, Alabama, where they resided at the time of their marriage and have resided continuously since.

Second: That your complainant and the said Virginia Jean Wilson, are husband and wife, having intermarried at Lucedale, Mississippi, December 31, 1955, and they lived together as husband and wife until September 25, 1957, when the said Virginia Jean

Wilson voluntarily abandoned this complainant without just cause and reasonable excuse; that the said Virginia Jean Wilson and this complainant have not lived together for more than twelve months next preceding the filing of this bill of complaint.

Third: That there was born to this complainant and the defendant one child, Grace Anita Wilson, who is two years old; that the said child is in the custody of your complainant at Loxley, Alabama; that the defendant is not a suitable person to have care and custody of the said child.

WHEREFORE your complainant prays that this Honorable Court will take jurisdiction of the cause made by this bill of complaint and make the said Virginia Jean Wilson party defendant hereto and by appropriate process require her to plead, answer or demur to the same within the time and under the pains and penalties prescribed by law and the practice of this Honorable Court;

Complainant further prays that upon the final hearing of this cause this Honorable Court will make and enter a decree forever dissolving the bonds of matrimony existing between this complainant and the said defendant; and complainant further prays that this Honorable Court will make and enter an order and decree awarding to this complainant the care and custody of the minor child, Grace Anita Wilson, and complainant prays for such other further or different relief as in equity and good conscience he shall be entitled to receive in the premises.




