Your Complainant, Reuben F. McKinley, respectfully represents unto Your Honor and this Honorable Court, as follows;

Your Complainant and Respondent married on to wit, August 1, 1953 and lived together until on to wit, August 2, 1958, when they seperated because of the cruelty of the Respondent.

Your Complainant is a bona fide resident of Baldwin County, **Akabahaz** Alabama and is over the age of twenty one years; The Respondent is over the age of twenty one years and her residence is unknown.

That on to wit July 31, 1958, the Respondent did run at the Complainant with a long butcher knife, when his back was half turned to her and she was only prevented from stabbing the Complainant by the Complainant picking up a chair and holding it between them, then dodging around the chair, grabbing the Respondent's arm and taking the butcher knife away from her. That on to wit August 2, 1958, the Respondent did, as she had done on several occasions prior thereto, threaten and abuse the Complainant, threaten to do violence to his person and actually did do violence to his person, which would necessarily endanger his life and health. The conduct of the Respondent was such that it gave the Complainant reasonable apprehension to believe and he did actually believe that if he continued to live with her, that she would carry out her threats and do actual violence to his person which would necessarily endanger his life and health.

That there are two children as fruits of this marriage, Rita Fay McKinley, age about 3 1/2 years and Carolyn Elaine McKinley, age about 1 1/2 years; that this Homorable court has heretofore granted custody of said children to the Complainant by decree dated September 19, 1957, September 2, 1958; that the Respondent on to wit August 2, 1958, in contempt of this Homorable court and in violation of its decree did and remove said minor children from the custody of the Complainant where they were, causing your Complainant a great amount of time, said children from the place where thay had been living, leaving no custody and control of said minor children and the Respondent is not.

Wherefore, the premises considered, your Complainant prays that Your Honor will by proper procedure make the said Lois Elizabeth McKinley Party Respondent to this Bill of Complaint, requiring her to plead, answer or demur to the same and within the time required by law and the ptactices of this Honorable Court;

Your Complainant further prays that upon a final hearing hereof, Your Honor will grant to him an absolute divorce, forever barring the bonds of matrimony existing between the Complainant and the Respondent; that your Honor will make a decree that the Respondent be taken into custody, wherever she may be found for violation of said decree of this Honorable Court and that the custody of said minor children be returned to your Complainant and your Complainant prays for such other, further, different or general relief as he may be in Equity and good conscience entitled to receive.
