That your Complainant and the Respondent are both over the ages of twenty-one years and are resident of Baldwin County, Alabama.

SECOND:

That the Complainant and the Respondent were married on, heretofore, to-wit, the 14th day of October, 1951 in La Mesa, California and lived together as husband and wife until on, to-wit, September 22nd, 1958, when, on account of the matters hereinafter complained of, your Complainant was forced to live separate and apart from the Respondent; that on the 22nd day of September, 1958 and at times prior thereto, the Complainant states that the Respondent, from his manner and conduct toward her, gave reasonable apprehension of committing violence upon her person, attended with danger to hear life and health, and that from his manner and conduct toward her, she is reasonably certain that if she continues to live with him as his wife, the Respondent will commit such actual violence upon her person, attended with danger to her life and health.

THIRD:

That no children have been born of this marriage between the Complainant and the Respondent and that the parties hereto have heretofore reached an agreement between themselves as to the disposition of their property and alimony to be paid to the Complainant and which stipulated agreement is attached hereto and made a part of this Bill of Complaint.

PRAYER FOR PROCESS AND RELIEF:

The premises considered, the Complainant prays that the above named Donald Bruce Perryman be made a party defendant to this cause by the usual writ or process of this Honorable Court requiring him to appear and plead, answer or demur within the time and under the penalties prescribed by the rules of this Court and the Statutes in such cases made and provided. That upon the final hearing of this cause, Your Honor will grant unto the Complainant an absolute divorce from the Respondent and will decree that the parties be allowed to remarry if they see fit. Complainant prays that Your Honor will grant that she resume her maiden name if she desires. Your Complainant further prays that she be granted such other, further and different relief to which she may be entitled and as in duty bound she will ever pray.
