This cause coming on to be heard was submitted for Final Decree on behalf of the Complainant on the Bill of Complaint as amended and the testimony taken in open court and the exhibits incidental thereto as transcribed and recorded by the Court Reporter, and on behalf of the Respondent on her Answer and Cross-Bill and the Answer to the Bill of Complaint as amended and the testimony taken in open court and the exhibits incidental thereto as transcribed and recorded by the Court Reporter; and the Court having considered all of the above is of the opinion that the Complainant is entitled to the relief prayed for in his original Bill of Complainant and that the Respondent and Cross-Complainant is not entitled to the relief prayed for in her Answer and Cross-Bill, but that she is entitled to an award in lieu of all alimony and support and to the custody of the minor child of the parties hereto; it is, therefore

ORDERED, ADJUDGED and DECREED by the Circuit Court of Baldwin County, Alabama, In Equity, as follows:

I. That the Complainant, Henry Tunstall, be, and he is hereby, forever divorced from the Respondent, Geraldine Tunstall, for and on account of cruelty; and that the bonds of matrimony heretofore existing between the parties hereto be, and they are hereby, dissolved.

2. That neither party to this suit shall again marry except to each other until sixty (60) days after the rendition of this decree, and that if an appeal is taken within said time, neither party shall again marry except to each other during the pendency of said appeal.

3. That the Respondent be, and she is hereby, awarded the

care, custody and control of Barbara J. Tunstall, a minor eighteen years of age, the child born to the parties hereto; subject, however, to the right of the Complainant to visit, and to have said child visit with him, at reasonable hours and at reasonable intervals.

4. That the Complainant pay to the said Barbara J. Tunstall until she reaches the age of twenty-one years or is married, whichever shall first occur, the sum of Twelve and 50/100 Dollars (\$12.50) per week for her maintenance and support; provided, however, that if, at the time the said Barbara J. Tunstall reaches the age of twenty-one she is enrolled in a recognized college then the payments herein provided for shall not cease but shall continue during the time of such enrollment. The payments herein ordered to be made shall be made direct to the said Barbara J. Tunstall and not to the Respondent for the use and benefit of Barbara J. Tunstall.

5. That the Complainant convey to the Respondent, in lieu of all alimony and support to which she is now entitled or to which she might hereafter be entitled, the undivided one-half $\binom{1}{2}$ interest owned by him in the following described real property situated in Baldwin County, Alabama, viz:

Comes the Respondent in the above styled cause and for answer to the bill of complaint filed therein, and to each and every paragraph and aspect thereof, separately and severally, says as follows:

FIRST:

Respondent admits allegations of paragraphs "FIRST" and "SECOND".

SECOND:

Respondent admits so much of paragraph "FOURTH" of the complaint as regards her minor daughter, Barbara J. Tunstall, but denies the allegation that she is able to support herself from her own earnings.

THIRD:

Respondent denies the allegations contained in paragraph "THIRD" of the complaint.

FOURTH:

Respondent further shows the Court that, for the sake of their minor child, she does not desire a divorce, but that she is entitled to support and maintenance from the Complainant, and the payment of her attorney's fees which have been entailed as a result of this action.

WHEREFOR THE PREMISES CONSIDERED, Respondent and Cross Complainant prays that Complainant be made a party of Cross Respondent to this a Cross Bill of Complaint and that so in hearing of this cause, his bill of complaint against her be dismissed of the cost assessed against him and that the Court hold and decree that she is entitled to separate maintenance and support from the Complainant, and to the payment of her solicitor's fee occasioned by this action. And Cross Complainant prays that a further and different relief as the Court may deem just in the premises.
