#### JUDICIAL CIRCUIT IN EQUITY:

Your Complainant, Emma Howell Covey respectfully represents unto your Honor that she is now and has been for more than three years next immediately preceding the filing of this Bill of Complaint, a bona fide resident of Tensaw in Baldwin County, Alabama; that she is of sound mind and over the age of twenty-one years and brings this complaint against Henry Covey who is of sound mind and over the age of twenty-one years and resides at or near Mt. Vernon in Mobile County, Alabama, and Complainant charges:

#### FIRST:

That in November 1913 she was lawfully married to Henry Covey at Tensaw in Baldwin County, Alabama, and lived with him as his lawful wife until the month of May 1921.

#### SECOND

That on or about the month of May 1921 the said Henry Covey without just cause voluntarily deserted and abandoned your - Complainant and has never since returned to her nor contributed to her support.

## PRAYER FOR PROCESS:

Your Complainant prays that such orders and decrees be made and entered as will make the said Henry Covey party respondent to this Bill of Complaint for divorce for abandonment; and that he be required to plea, answer or demur to this Bill of Complaint within the time allowed by law or that the same be conferred against him.

## PRAYER FOR RELIEF:

Your Complainant further prays that upon final hearing of this cause that your Honor will grant unto her a decree of divorce from the bonds of matrimony from the said Henry ovey and to grant to her such other and further or different relief as to your Honor may seem just and proper and as in duty bound she will ever pray etc.

The Respondent, Henry Covey is required to answer each and every allegation and paragraph of the above complaint from One to Two inclusive but not under oath, as oath to the same is hereby expressly waived.
