

That the said Josie Virginia Minchew Hadley file a certified copy of this decree in the office of the Judge of Probate of Baldwin 🥬 County, Alabama, and in each of the counties in which said minor shall hereafter reside, and in the office of the Judge of Probate in each county in the State where said minor shall do any business or make any contracts.


