My name is Robert Lee Troup and I am the Complainant in the above styled cause. I am over the age of twenty-one years and a resident citizen of Silverhill, Baldwin County, Alabama.

I was married to the Respondent on the 15th day of January. 1947 at Fairhope, Alabama. I had previously been married to Respondent in Birmingham, Alabama but was divorced from that marriage. We were remarried at the insistence of the Respondent that a reconciliation could be made. However, the marriage was entirely unsatisfactory and although the Respondent and I have lived under the same roof since that marriage, we have not lived as husband and wife and have had no marital relations for approximately ten years. We have occupied separate rooms and beds and have not recognized each other in any manner as husband and wife for more than one year next preceding the filing of this cause and have not done so for many years prior to this date.

#### FIRST:

That your Complainant and the Respondent are over the age of twenty-one years and are resident citizens of Baldwin County, Alabama, residing at RFD, Silverhill, Baldwin County, Alabama.

#### SECOND:

That the Complainant and Respondent were married at Fairhope, Alabama on the 15th day of January. 1947, and lived together as husband and wife until, on account of the matters hereinafter complained of, your Complainant lived separate and apart from the Respondent. That there were born of this marriage between Complainant and Respondent the following named minor children, viz: Betty Jane Troup, age seventeen years and Charles Leslie Troup, age nineteen years; that the Complainant and Respondent have and are jointly possessed of certain real and personal property. The Complainant further avers that Complainant and Respondent have heretofore entered into an agreement pertaining to the care, custody and control of the said minor children and the disposition of real and personal property between themselves; a copy of which agreement is attached hereto and made a part of this Bill of Complaint as if set forth herein.

### PRAYER FOR PROCESS AND RELIEF:

The parties are jointly possessed of certain real and personal property located in Baldwin County, Alabama and which property the parties hereto agree to dispose of as follows:

#### REAL PROPERTY

The Complainant shall convey to Respondent that certain parcel of land being the NW $\frac{1}{4}$  of the SE $\frac{1}{4}$  of Section 17, T6S, R3E, containing 40 acres, more or less. Together with all improvements located thereon and consisting of a dwelling house and all out-buildings.

The Respondent shall convey to Complainant that certain parcel of land being the  $NE_{4}^{\frac{1}{4}}$  of the  $NW_{4}^{\frac{1}{4}}$  of Section 20, T6S, R3E, containing 40 acres, more or less.

#### PERSONAL PROPERTY

The Complainant, for and in consideration of the agreements herein stated, does hereby grant, bargain, sell and convey unto Respondent all his right, title and interest in and to the following personal property:
