DECREE MOVING GUARDIANSHIP TO EQUITY COURT

This cause coming on to be heard on this date is submitted on sworn petition of W.M. Kelly, Guardian of the said Mattie Cumbie, a non compos mentis, which has been filed in this Court on this date, from which it appears that the said W.M. Kelly has been duly appointed as Guardian, and has so qualified, said guardianship now pending in the Probate Court of Baldwin County, Alabama; that because of the broader powers of this Court, this said guardianship can better be administered in this Court than in the Probate Court of Baldwin County, Alabama, upon the consideration of all of which it is, therefore,

ORDERED, ADJUDGED and DECREED by the Court as follows:

1. That the administration of this guardianship be and is hereby removed from the Probate Court of Baldwin County, Alabama, to the Circuit Court of Baldwin County, Alabama, in Equity.

2. That the Register of this Court shall forthwith deliver a copy of this Decree to the Judge of Probate of Baldwin County, Alabama, who shall immediately transfer all papers and proceedings in connection with guardianship of said Mattie Cumbie, non compos mentis, in the Probate Court to this Court.


PETITION TO REMOVE ESTATE TO EQUITY COURT
