MOTION TO DISMISS APPEAL:

Comes Nancy Selden Wright as Executrix of the Last Will and Testament of Imogen I. Albrizio, Deceased, and objects to trial in this court and moves the court for a discontinuance as to the claim of Conrad Albrizio and for a dismissal of the purported appeal of Conrad Albrizio from the judgment of the Probate Court of Baldwin County, Alabama, denying the claim of Conrad Albrizio and as grounds therefor sets down and assigns the following separate and several grounds, to-wit:

- 1. The judgment of the Probate Court of Baldwin County, Alabama, denying the claim of Conrad Albrizio was rendered in said court on December 16, 1959, and no appeal was or has been taken from said judgment within thrity days after the rendition of said judgment in manner and form provided by law.
- 2. No appeal herein was or has been perfected in manner and form provided by law.
- 3. No appeal herein was or has been perfected within the time allowed by law.
- 4. No appeal from the judgment of the Probate Court of Baldwin County, Alabama, denying the claim of Conrad Albrizio was perfected by anyone giving security for the costs of such appeal, approved by the Judge of Probate, as required by law.
- 5. No appeal bond, Supersedeas Bond or other security for costs was filed by or for Conrad Albrizio for appeal from the judgment of the Probate Court of Baldwin County, Alabama, and the attempted or purported appeal from the judgment of the Probate Court of Baldwin County, Alabama, denying the claim of Conrad Albrizio is abortive and was not taken or made in the manner and within the

time provided by law.

CLAIM OF CONRAD A. ALBRIZIO

Comes now Conrad A. Albrizio, widower of said decedent, and who is over the age of twenty-one (21) years and resides in Foley, Baldwin County, Alabama, and makes and files the following separate and several claims against the estate of said decedent, that is to say:

- 1. Claimant claims the sum of Eight Hundred Thirty-Seven and 25/100 Dollars (\$837.25), with interest thereon from, to-wit, October 14, 1958, for monies advanced by claimant for the payment of the invoice of Roche Undertaking Company, Mobile, Alabama, for funeral expenses of said decedent, which sum has never been paid to the claimant, and all of which is justly due and owing and the property of the claimant, and there are no credits against the same.
- 2. Claimant claims the sum of One Hundred Forty and no/100 Dollars (\$140.00) with interest thereon from, to-wit, October 10, 1958 and October 22, 1958, respectively, for monies paid to R. Spurway (\$42.00) and Ann Snyder (\$98.00), both of whom were trained nurses, for services rendered by each of them, as such, to the said decedent during her last illness.
- 3. Claimant claims the sum of Six Thousand Dollars (\$6,000.00) with interest thereon from, to-wit, May 9, 1945, being the claimant's one-half of proceeds of the sale of a house and lot in Baton Rouge, Louisiana, which was sold to a Mr. LaMar, and which proceeds were retained by the said decedent; claimant claims that he is entitled to one-half of such proceeds as the husband of said decedent.
- 4. Claimant claims the sum of Twenty Thousand One Hundred Eighty and 84/100 Dollars (\$20, 180.84) for monies paid by the claimant between the period March, 1950 and May, 1958 in the improvement of

homestead properties known as "Tidewater" situated at Bon Secour in Baldwin County, Alabama, which improvements were placed on land to which the said decedent held the legal title; claimant claims an equitable lien on said land and the improvements for said expenditures with interest thereon, all of which is justly due and owing to the claimant after allowing all credits against the same.

- 5. Claimant claims the sum of Three Thousand Four Hundred Twenty and no/100 Dollars (\$3,420.00) with interest thereon from February, 1948, for monies expended by claimant in the construction and improvement of lands at Shell Banks in Baldwin County, Alabama, legal title to the land being held by the decedent, which land was subsequently exchanged by claimant and decedent to George C. Meyer, or to one of his corporations, for said lots at Gulf Shores, which were subsequently sold and the proceeds thereof collected by the decedent and were unaccounted for; claimant will impress said proceeds with a trust and equitable lien, and claims an accounting therefor, all of which is justly due and owing to the claimant and remains unpaid after allowing all just credits against the same.
- 6. Claimant claims the sum of Fifty Thousand Dollars (\$50,000.00) damages for the breach of a contract made by the said decedent with the claimant in which the decedent, in substance, agreed to devise to the claimant the absolute title in fee simple to the homestead property situated at Bon Secour in Baldwin County, Alabama known as "Tidewater", together with the contents thereof, and a lot of land at Gulf Shores known as Lot No. 13, Unit 6 of Gulf Shores, Alabama, which properties were acquired with funds belonging to claimant(with the exception of approximately Three Thousand Dollars (\$3,000.00) furnished for the purpose by the decedent); claimant is informed by attorneys representing the estate of said decedent that under the will of said decedent, neither of said properties will be vested in the claimant absolutely or in fee simple, but that on the contrary

the properties will be sold to pay debts of said estate, which efforts the claimant will resist as being contrary to said agreement between the claimant and said decedent and a breach of duty by said decedent and by said attorneys to this claimant, and contrary to law.

Claimant presents each of the foregoing claims and files the same in the office of the said Judge of Probate, this statement of said claims being verified by the oath of the claimant who has knowledge of the correctness thereof; the amounts claimed above being justly due to the claimant after allowing all proper credits.
