TO THE HONORABLE HUBERT M. HALL, JUDGE OF THE CIRCUIT COURT OF BALDWIN COUNTY, ALABAMA, SITTING IN EQUITY:

Your Complainant, Audrey Kay Volking, a minor, by Alice Volking, as her next friend, presents this Bill of Complaint against Dean Keith, and thereupon shows unto the Court and your Honor as follows:

- l. Complainant, Audrey Kay Volking, is a minor fourteen years of age and brings this suit by Alice Volking, who is her mother, and next friend and both of whom are residents of Baldwin County, Alabama. The Respondent, Dean Keith, is over the age of twenty-one years and a resident of Baldwin County, Alabama.
- 2. That a marriage ceremony was performed between your Complainant and the said Respondent in Fairhope, Baldwin County, Alabama, on to-wit, August 21, 1959, under a marriage license issued by the Probate Court of Baldwin County, Alabama.
- 3. That your Complainant has learned since the said marriage ceremony that the Respondent was legally married at the time the said ceremony took place, having heretofore married Myrtle Taylor at Brewton, Alabama, on June 28, 1958, and that on August 21, 1959, the Respondent's wife was living and they were legally married on that said date, all of which was unknown to Complainant; that as soon as Complainant learned the true marital status of the Respondent she separated from the said Respondent and they have not lived together since as man and wife.

The premises considered, your Complainant makes the said

Dean Keith a party respondent to this her Bill of Complaint and

prays that service may be had upon him in the manner prescribed by

law, and that he be required to plead, answer or demur to this Bill

of Complaint within thrity days after such service, and that upon

a hearing hereof your Complainant prays that this Honorable Court

will enter a decree adjudging and declaring the said marriage

ceremony between your Complainant and the said Respondent to be null

and void, and that the marriage relation does not exist between

your Complainant and the said Respondent, Dean Keith, and that said marriage relation has never existed between your Complainant and the Respondent.
