Comes your Complainant, Janie Lyman Driscoll, and files this her Bill of Complaint for divorce against Robert E. Driscoll, and shows unto Your Honor and unto this Honorable Court as follows:

FIRST:

That your Complainant and the Respondent are both over the age of twenty-one years and that your Complainant is a resident of Baldwin County, Alabama for more than one year next preceding the filing of this Complaint. The Respondent is a resident of the State of New York, residing in Buffalo, New York.

SECOND:

That your Complainant and the Respondent were married on, heretofore, to-wit, the 17th day of January, 1942 in Amhurst, New York and lived together as husband and wife until on, to-wit, the 30th day of April, 1959, when, on account of the matters hereinafter

complained of, your Complainant was forced to live separate and apart from the Respondent; that on April 30, 1959 and at times prior thereto, Complainant states that the Respondent, from his manner and conduct toward her, gave reasonable apprehension of committing violence upon her person, attended with danger to her life and health, and that from his manner and conduct, she is reasonably certain that if she continues to live with him as his wife, he will commit actual violence upon her person with danger to her life and health or may injure her permanently.

THIRD:

That there have been three children born of the marriage between your Complainant and the Respondent, namely, Janie Driscoll, aged 17 years, Robert E. Driscoll, Jr., aged 14 years, and Claudia Driscoll, aged six years. That your Complainant and the Respondent have heretofore reached an agreement between themselves as to the disposition of their property and the custody of the children.

PRAYER FOR PROCESS AND RELIEF:

The premises considered, your Complainant prays that the above named Robert E. Driscoll be made a party Defendant to this cause by the usual writ or process of this Honorable Court requiring him to appear and answer, plead or demur within the time and under the penalties prescribed by the rules of this Court and the Statutes in such cases made and provided; that upon a final hearing of this cause Your Honor will grant unto Complainant an absolute divorce from the Respondent and will decree that they be allowed to remarry if they see fit. Should your Complainant be mistaken in the relief prayed for, that there be granted to her such other, further and different relief to which she may be entitled and as in duty bound she will ever pray.
