WHEREFORE the premises considered your Petitioner prays that your Honor make and enter a decree relieving Dawn Pullen of the disabilities of non age and that such other proceedings be had and such further orders and decrees be made as may be necessary in the premises and as will invest the said minor with the right to sue and be sued, contract and be contracted with, buy, sell and convey real estate and to generally do and perform all acts which she could lawfully do if she were twenty-one years of age.

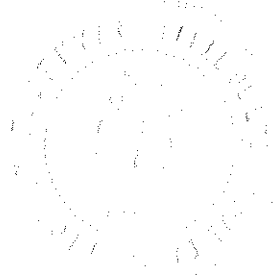
