Your Complainant, Mary Mell Rider Fuqua, respectfully represents and shows unto your Honor and this Honorable Court as follows:

That on to-wit, January 3, 1953, and on various other occasions, the Respondent cursed, threatened and abused your Complainant and threatened to do violence to her person which would necessarily endanger her life and health; that the conditions of the Respondent was such as to give your Complainant every reasonable apprehension to believe, and she did actually believe that if she continued to live with him he would carry out his threats and do actual violence to her person that would necessarily endanger her life and health.

That there was born between the marriage of your Complainant and the

Respondent nine children, PEGGY FERRELL FUQUA, age 11; THOMAS FUQUA, age 11; GENE ARTHUR FUQUA, age 10; HEREERT FUQUA, age 9; LloyD FUQUA, age 6; PATRICIA FUQUA, age 3; MARYLENE FUQUA, age 2; HETTY JEAN FUQUA, age 2; and DIANA FUQUA, age 3 months; that said children are with your Complainant who is a suitable, fit and proper person to have their care, custody and control.

Your Complainant avers that said Respondent is a man of considerable income; to-wit: receiving from his employer a salary of \$250.00 per month.
