

Your Orator, Shirley Powell, respectfully represents and shows unto Your Honor as follows:-

### FIRST:

That he is a bona fide resident citizen of Baldwin County,
Alabama, residing at Bay Minette, Alabama, and has resided in Baldwin County,
Alabama, for more than three years next preceeding the filing of this bill;
that he is over the age of twenty one years.

#### SECOND:

That Ruby F. Powell is a resident citizen of Baldwin County,
Alabama, residing at Bay Minette, Alabama; that she has resided in Baldwin
County, Alabama, for more than three years next preceeding the filing of this
bill; that she is over the age of twenty one years.

#### THIRD:

married on the 22nd., day of July . 1926, and lived together as husband and wife until, to-wit: August 6th., 1926, at which time the said Ruby F. Powell committed the act of adultery with one Willard Powell; that your orator did not connive or condone said offense; said act was committed in Baldwin County, Alabama.

THE PREMISES CONSIDERED Your Orator respectfully prays that
the said Ruby F. Powell be made partyrespendent to this bill of complaint by
the usual process of this Honorable Court; that such orders, decrees and
publications be made as necessary to perfect service on the said Ruby F. Powell,

and that she be required to demur, plead to or answer the same within the time and under the penalties as provided by law, or that the same be forever confessed.

That upon the final hearing of this cause Your Honor will grant unto Your Orator an absolute divorce from the said Ruby F. Powell.

PRAYER FOR RELIEF.

That if Your Orator is mistaken in the relief prayed for them Your Honor will grant unto him such other, further, differenet and general relief as he may in justice and equity be entitled, he will ever pray, etc.,
