- l. Huber is over the age of eighteen years and is a resident of Loxley, Baldwin County, Alabama.
- 2. That the complainant and respondent were lawfully married on or about to-wit: March 15, 1952 at Pascagoula, Mississippi; and of this marriage there are no children.
- 3. Your complainant further avers and alleges that said respondent has been guilty of adultery with divers parties and persons.

The premises considered, your complainant makes the said Vivian W. Huber, a party respondent to this bill of complaint, and in order that the complainant may have the relief herein prayed for, May it please your Honor to cause the State's writ of subpoens to be issued, directed to the said Vivian W. Huber, commanding her to answer, plead or demur to this bill of complaint, within the time required by law; and that on a final hearing of this cause, that your Honor will enter a decree divorcing your complainant from the said respondent, and that your Honor will grant such other, further or different relief as unto your Honor will seem just and proper.
