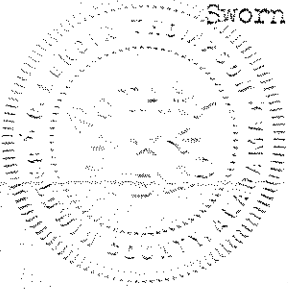

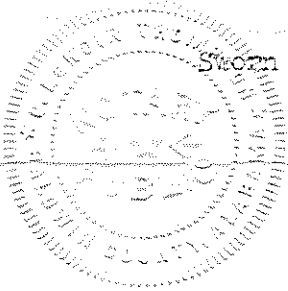

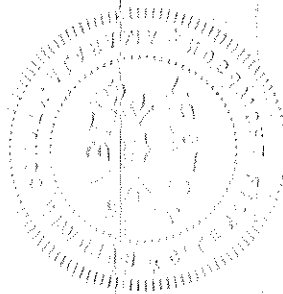

Alabama and the minor, Denny Louis Bertolla is a resident of Loxley, Alabama.

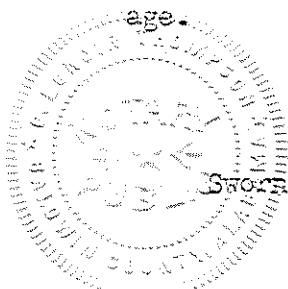
WHEREFORE the premises considered your Petitioner prays that your

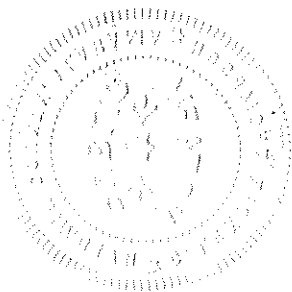

IN THE MATTER OF:

This cause now coming on to be heard is submitted for a final decree upon the petition, notices and affidavits as shown by a note of submission; and, upon consideration thereof, the court is of the opinion and finds that all the allegations of the petition are true: That the said Denny Louis Bertolla is a minor over the age of eighteen years and under the age of twenty-one years; that he is a resident of Baldwin County and is for his age a person of mature judgment, of sober and industrious habits, and is competent and capable in every way of handling his own affairs, and is the owner of property; that the said Helen Bertolla Jacobs is duly and legally appointed guardian of the said minor and has joined in his petition for the removal of the disabilities; the court further finds that it is to the interest of such minor to grant the prayer of his petition it is, therefore,

Ordered, adjudged and decreed by the Court:

1. That the said Denny Louis Bertolla be and he is hereby relieved from the disabilities of non-age and is now invested with the right to sue and be sued, contract, to buy, sell and convey real estate, and in general to do and perform all acts which such minor could lawfully do if he were twenty-one years of age.

2. That the said Denny Louis Bertolla file a certified copy of this decree in the office of the Judge of Probate of Baldwin County, Alabama, and in each of the counties in which said minor shall hereafter reside, and in the office of the Judge of Probate in each county in the State where said minor shall do any business or make any contracts.

3. That the petitioners pay the costs of these proceedings to be taxed by the register, for which execution may issue.
