

KNUW ALL MEN BY THESE PRESENTS, that this agreement made and entered into on this the 22nd day of January, 1945, by and between CLARA ELIZABETH LEE, first party and LAWRENCE LEE, second party, witnesseth:

- 1. WHEREAS, the patties hereto are husband and wife and have come to the conclusion that they can no longer live together;
- 2. WHEREAS, they have reached a full and complete settlement as to the custody of their three minor children, and as to all alimony.
- 3. NOW THEREFORE these presents witnesseth that the first party shall have the care and custody and control of the three minor children, Mylan Lee, Ladon Lee, and Evon Lee; that the Respondent shall have the right to visit them at reasonable times; that the second party will pay to the first party, the sum of \$20.00 per week for the maintenance and support of said children; that the first party will accept the sum of \$20.00 per week to be paid by the second party; that the said amount will be paid by the second party to the first party on Saturday of each week, the first payment to be due and payable on the 27th day of January, 1945, and a like payment on each Saturday thereafter.

TO HONORABLE F. W. HARE, JUDGE OF THE CIRCUIT COURT OF BALDWIN COUNTY, ALABAMA, IN EQUITY:

Now comes your Complainant, Clara Elizabeth Lee, and humbly complaining against the Respondent, Lawrence Lee, respectfully represents and shows unto your Honor and this Honorable Court as follows:

That the Complainant and the Respondent are both bona fide residents of Baldwin County, Alabama, and are over twenty-one years of age;

That your Complainant and the Respondent were married at McKenzie, Alabama, on November 6, 1937, and lived together as husband and wife until about the 15th of November, 1944;

3.

That on to-wit November 15, 1944, and at various times prior thereto, the Respondent threatened and abused the Complainant and often threatened to do violence to her person which would necessarily endanger her life and health; that the conduct of the Respondent was such as to give the Complainant every reasonable apprehension to believe, and she did actually believe that if she

continued to live with him he would carry out his threats and do violence to her person which would necessarily endanger her life and health.

4.

That there was born to said marriage between your Complainant and the Respondent, three children; Mylan Lee, age 6, Ladon Lee, age 3, and Evon Lee, age 7 months, whom are now and have been all their lives with the Complainant, who is a suitable and proper person to have their care, custody and control.

WHEREFORE, the premises considered, Complainant prays that your Honor will, by proper process, make the said Lawrence Lee party Respondent to this cause of action, requiring him to plead, answer or demur to the same within the time and under the penalties prescribed by law and the practice of this Honorable Court.

Complainant further prays that your Honor will, upon the hearing hereof, enter an order and decree, granting to the Complainant an absolute decree of divorce, forever barring the bonds of matrimony existing between her and the Respondent; and that she be awarded the care, custody and control of the said minor children; Mylan Lee, Ladon Lee, and Evon Lee.

Complainant prays for such other, further, different or general relief as she may be in equity and good conscience entitled to receive, and as in duty bound she will ever pray.
